

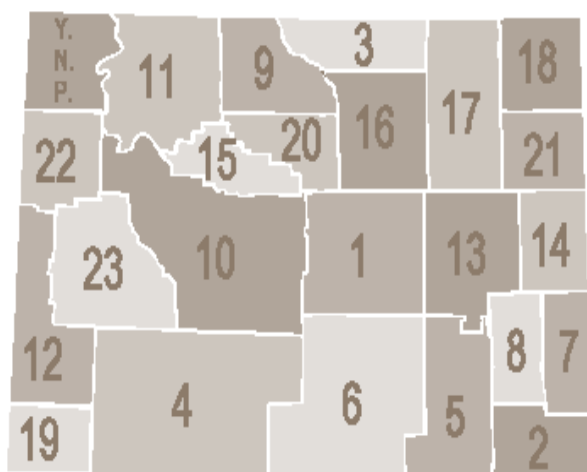


COUNTY PROFILES

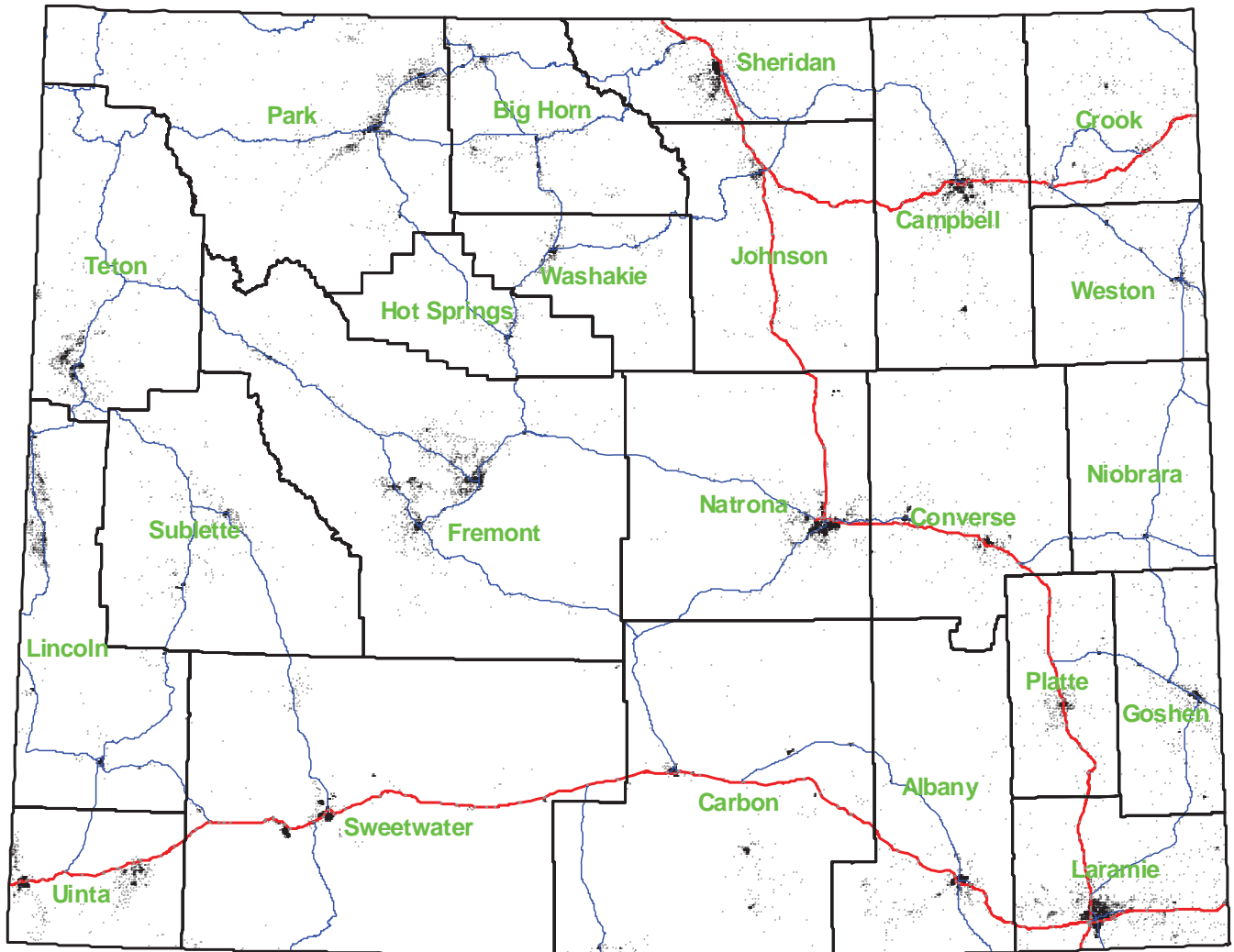
