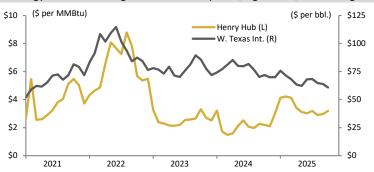

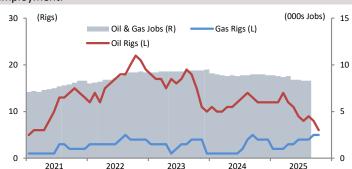

▶ Energy index: natural gas and crude oil prices, rig counts, and oil & gas employment. 1,3,8,11



▶ The West Texas Intermediate crude oil price averaged \$60.89 in October, 4.8% less than the previous month and 15.4% less than a year ago. The Henry Hub natural gas price averaged \$3.20 per MMBtu in October, \$0.23 more than a month ago and \$1.00 more than October 2024.



▶ Oil & gas jobs numbered 8,300 in August, 600 less than the total a year ago. Average active oil rigs were 6 in October while the conventional gas rig count was 5. Note: Oil & gas jobs include both the NAICS 211 (oil and gas extraction) and NAICS 213 (support activities for mining) subsectors.

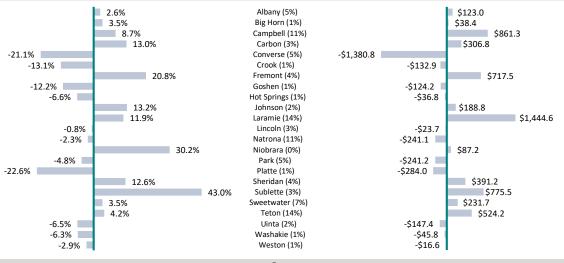

▶ State & local shares of 4% sales and use tax collections. [Change by County: October 2025 vs. October 2024 by percent and dollars (in thousands)]

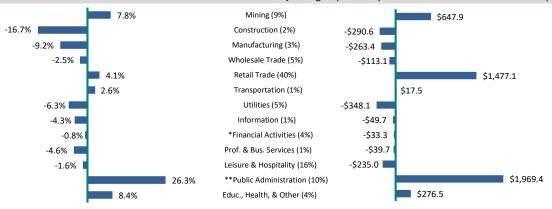


▶ In a year-over-year comparison (October 2025 vs. October 2024), sales and use tax collections statewide increased by \$3.0 million or 3.3%. 12 of the 23 counties saw a year-over-year increase in collections.

Laramie County saw the largest increase in collections, up \$1.4 million (+11.9%). Sublette County experienced the largest percent increase in collections, up 43.0%.

Note: Collections in October primarily reflect sales in September.

▶ State & local shares of 4% sales and use tax collections. [Change by Industry: October 2025 vs. October 2024 by percent and dollars (in thousands)]



▶ In a year-over-year comparison (October 2025 vs. October 2024) by industry, the public administration sector experienced the largest increase in collections, up \$2.0 million (+26.3%). The mining sector also saw an increase in collections, up \$0.6 million (+7.8%). This is the first year-over-year increase in collections from the mining sector since April 2024.

Note: Value in parentheses represents share of total collections.

*Taxes are mostly from automotive, machinery, and equipment leasing and rental.

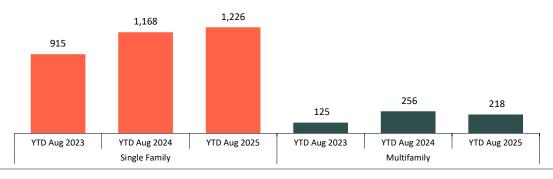


▶ Wyoming had 297,500 jobs in August, 2,600 more than August 2024, an increase of 0.9%. Leisure & hospitality added the most jobs in August (+1,500), while mining lost the most jobs (-1,100).

Note: Value in parentheses represents share of total jobs.

▶ Residential building permits. 10 [Comparisons: Single family and multifamily units]



➤ Single family housing units permitted through August 2025 increased by 58 (+5.0%) compared to 2024. The number of multifamily units decreased by 38 (-14.8%) during the same period compared to 2024.
