Increasingly Solid National Economy

The economic recovery is gaining traction:

- Job growth – largest 3 month increases since 2006.
- Unemployment insurance claim – lowest in 4 years.
- Consumer confidence is rising – highest in 4 years.
- Companies are in excellent financial shape.
- Manufacturing is growing stronger.
- Automobile sales are gaining – highest in 4 years.
- Construction has turned the corner.
- Europe threat is subsiding.
- Banks are lending.
- Stock market is rising.

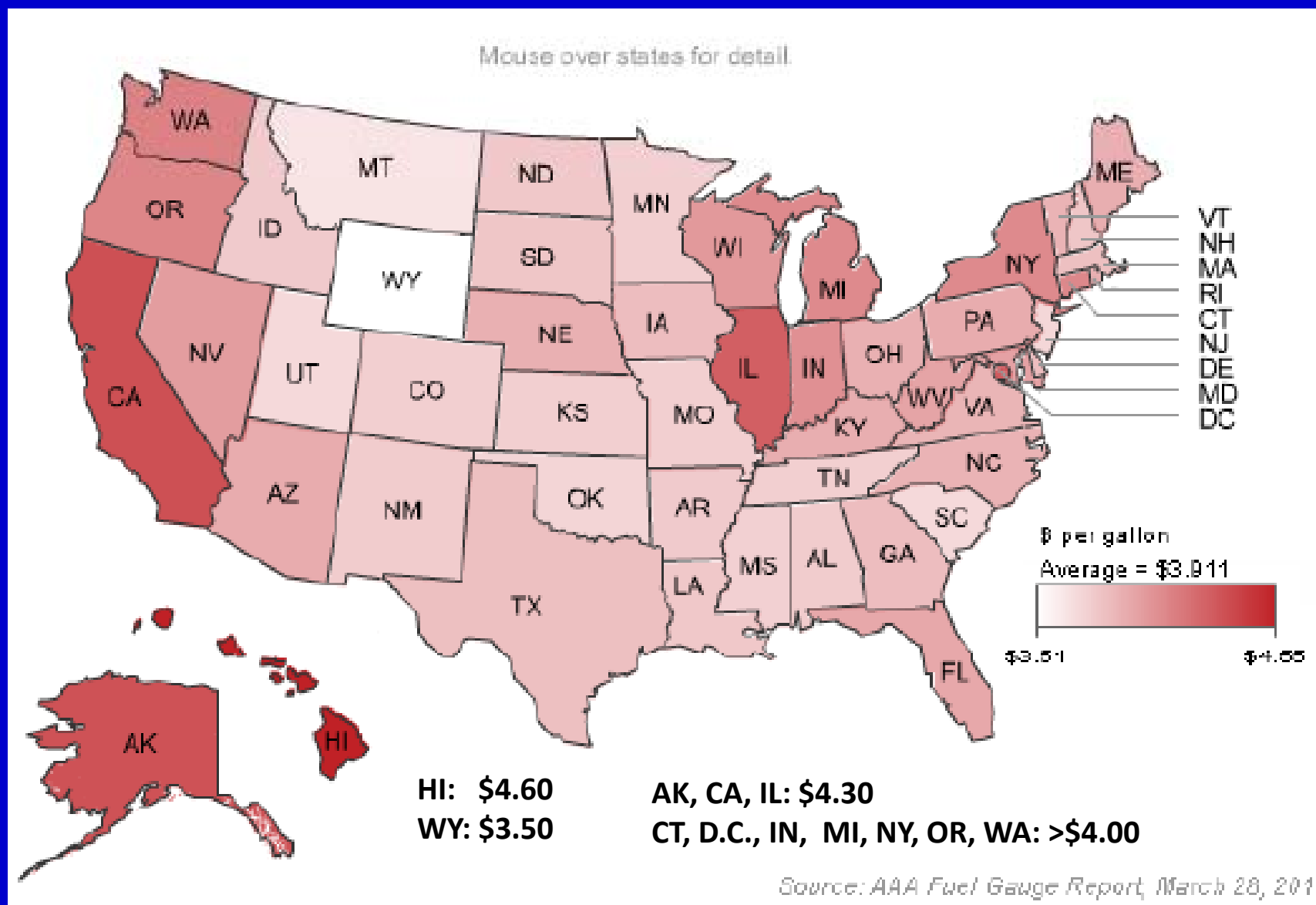
Negative factors:

- Surging gasoline price.
- Still depressed housing market.
- Slower growth in emerging markets.
- Long term deficit.

One dot = 7500 people

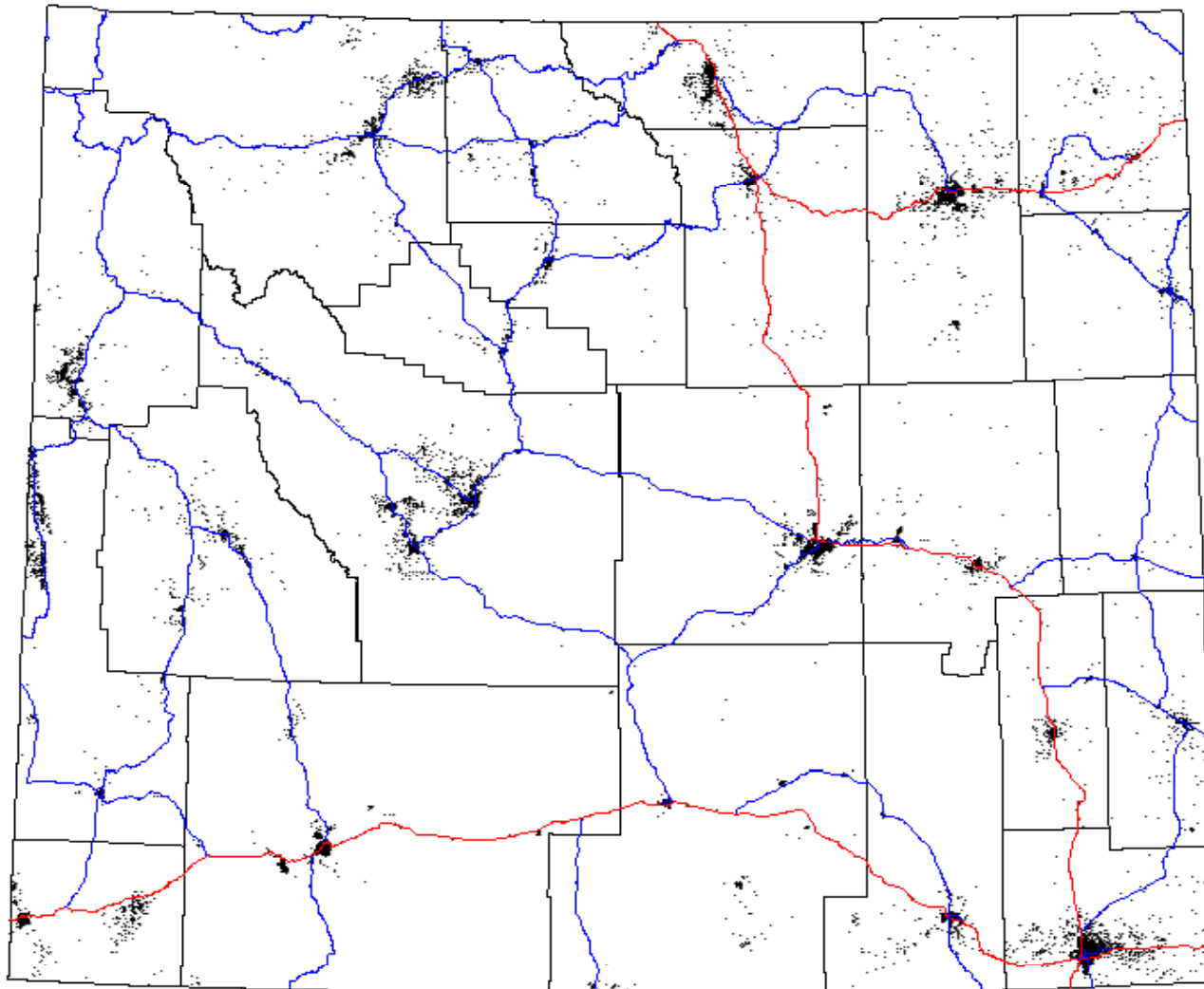

1 dot = 20 persons

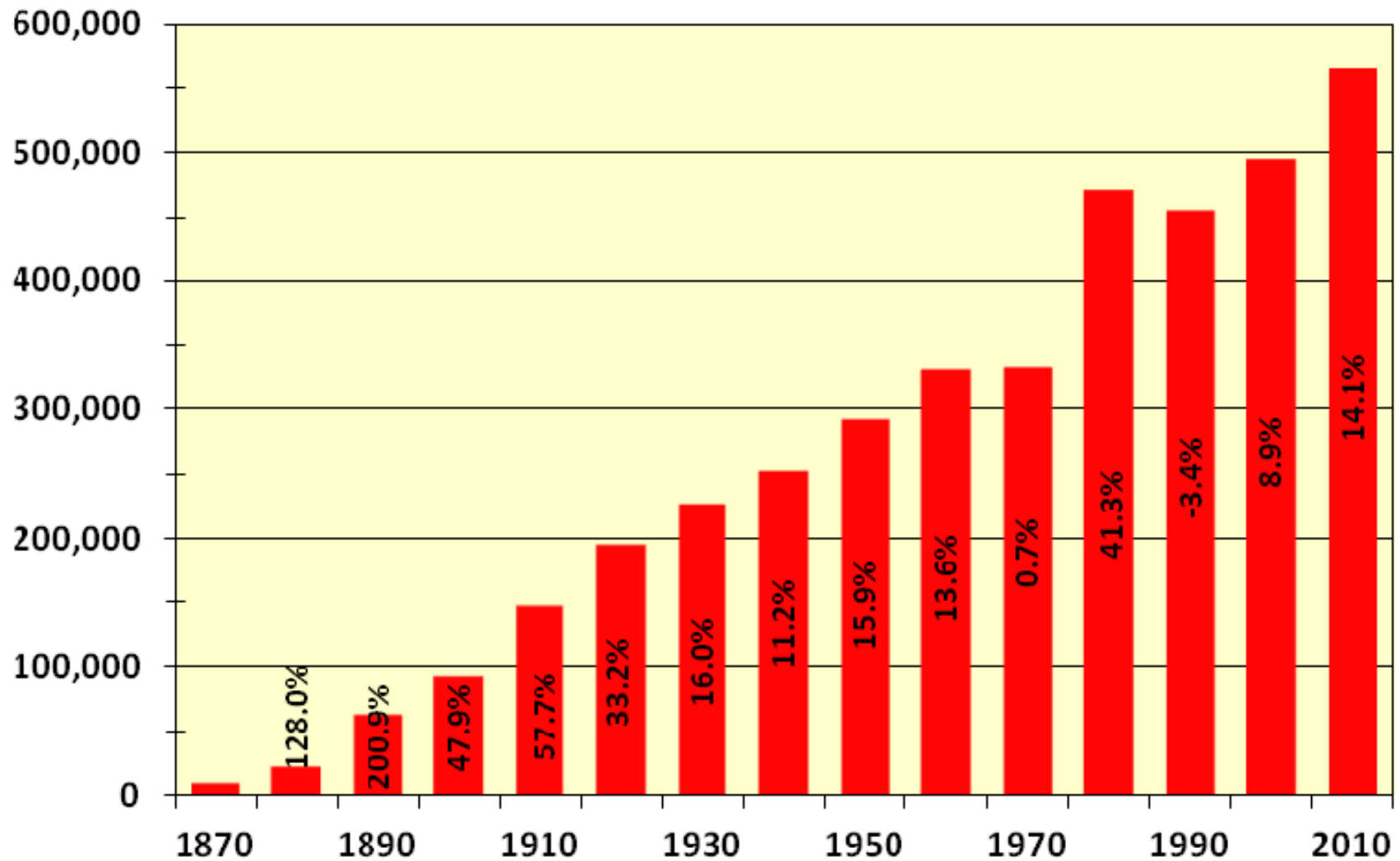

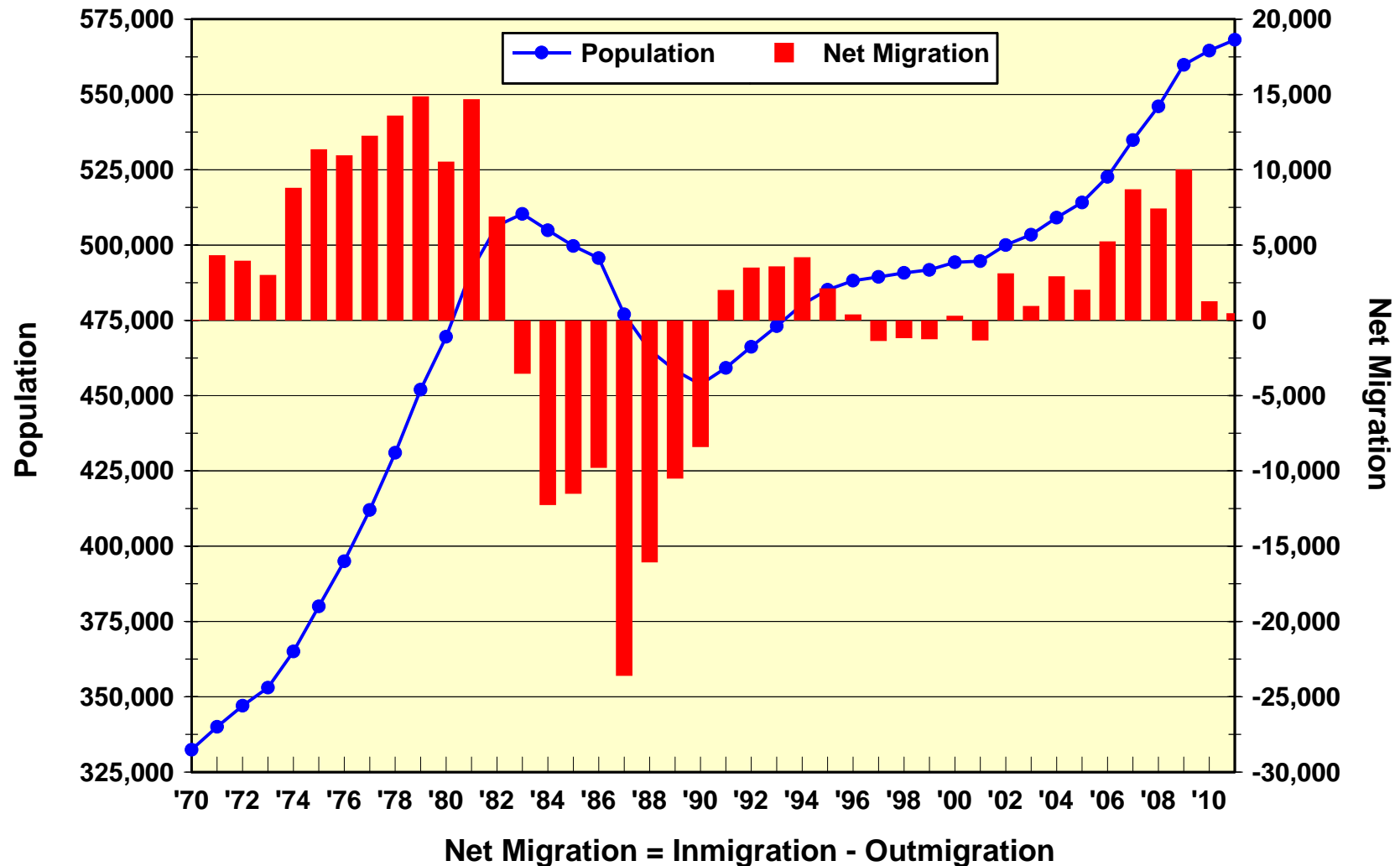

Wyoming Population and Net Migration: 1970 to 2011

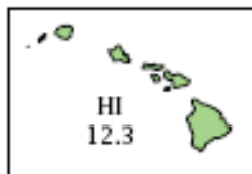
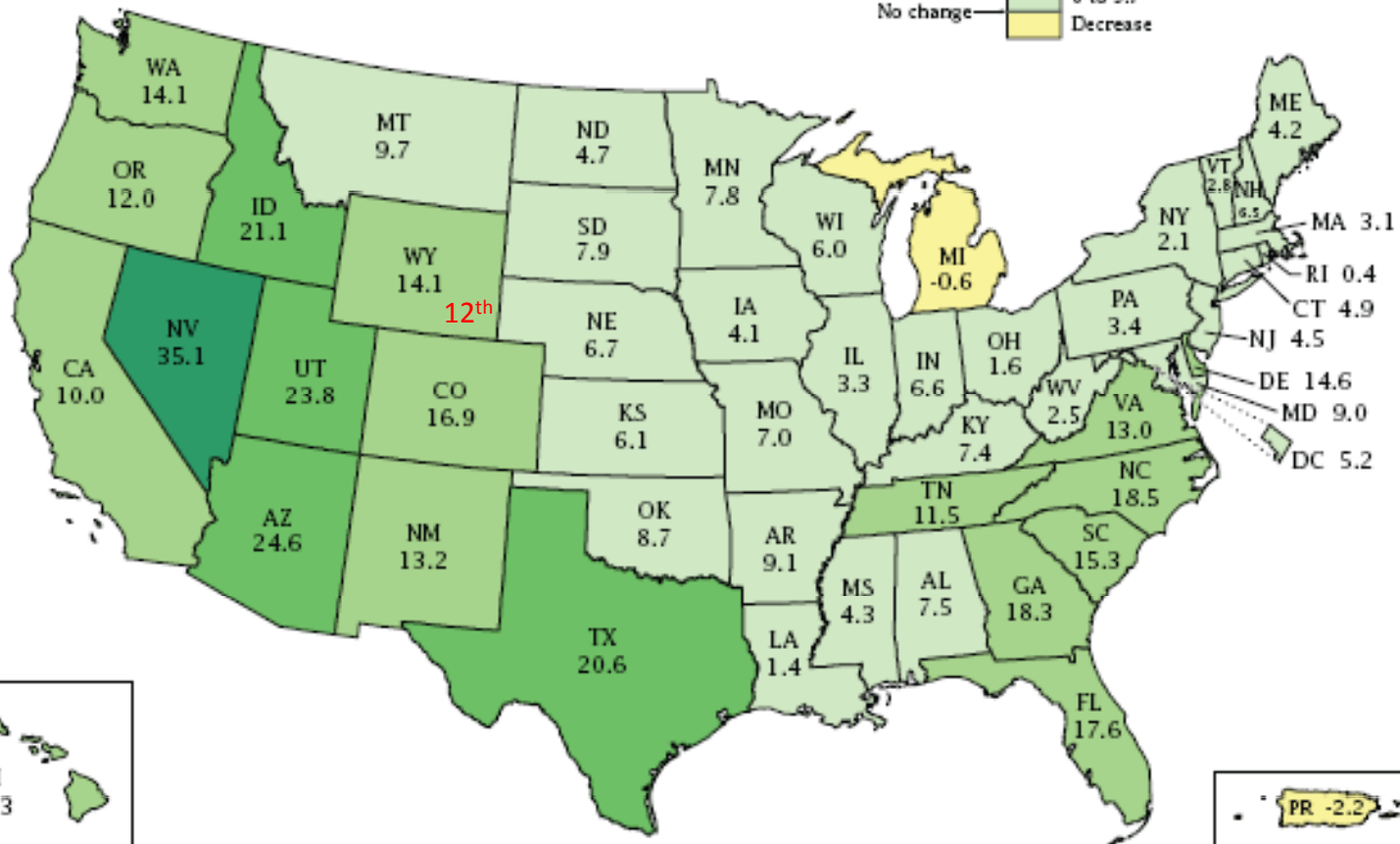
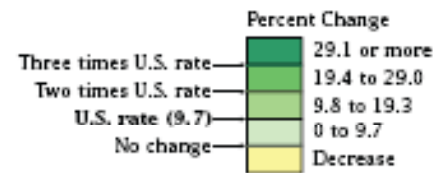

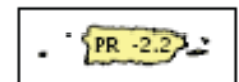

Percent Change in Resident Population for the 50 States, the District of Columbia, and Puerto Rico: 2000 to 2010

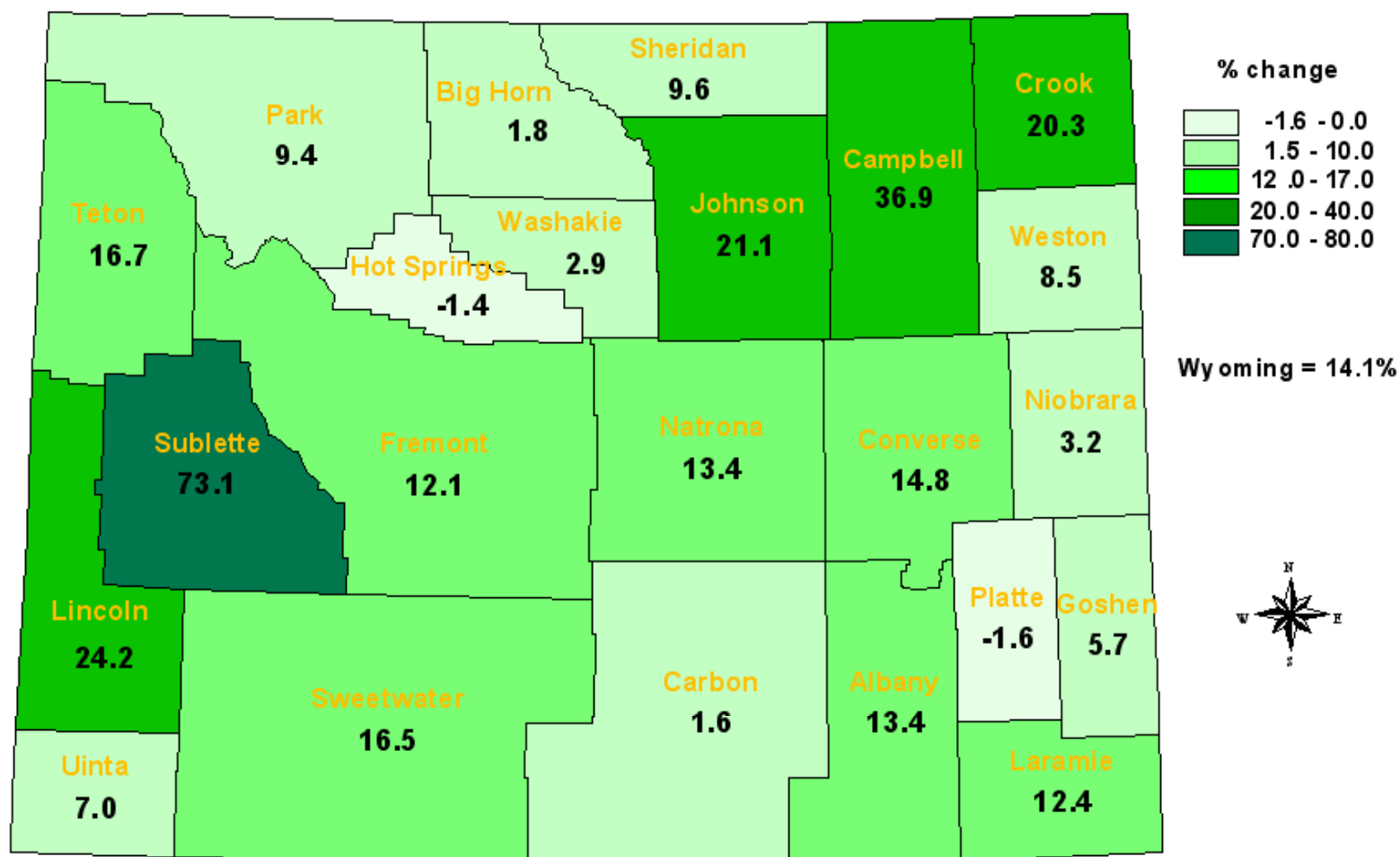

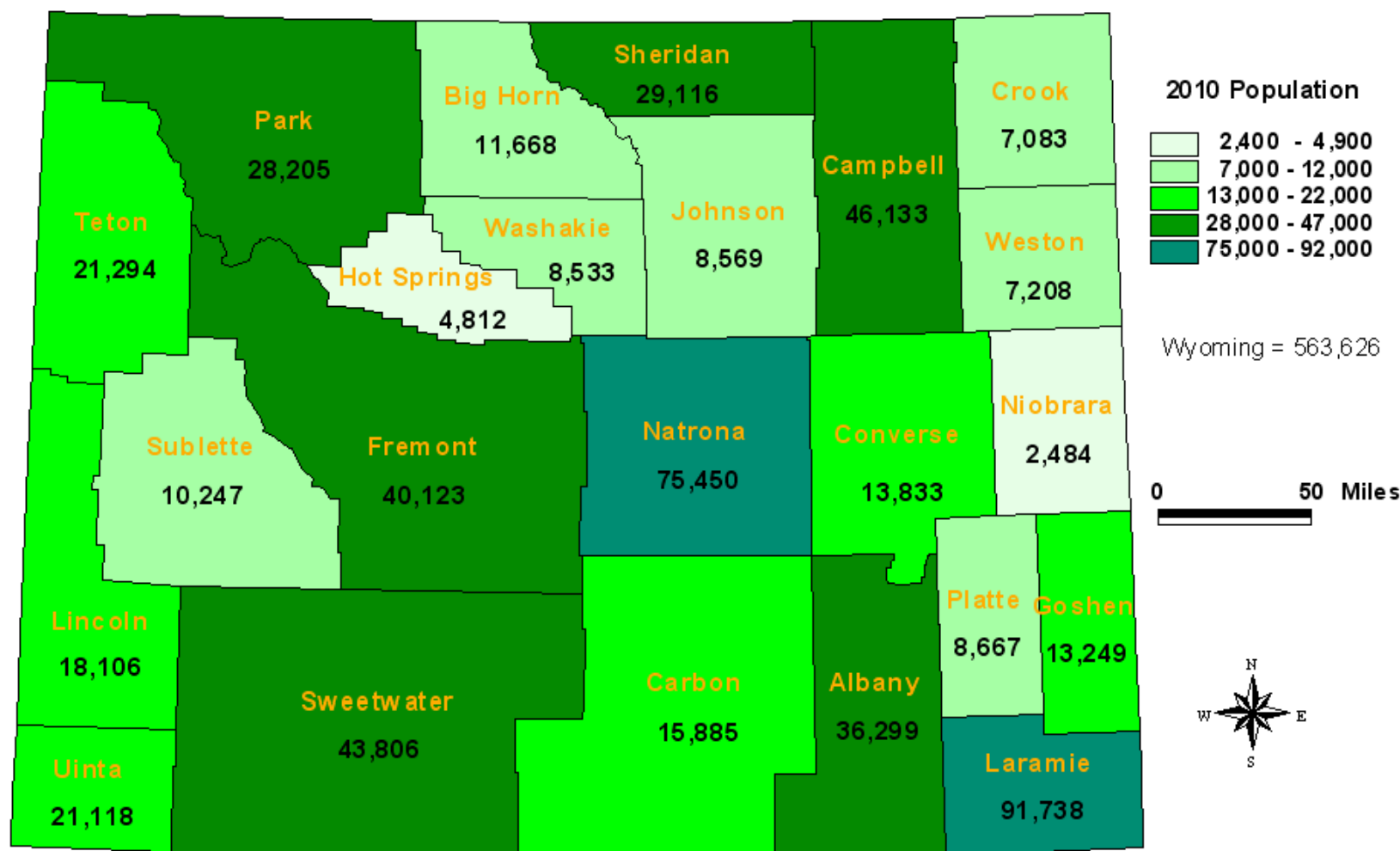
Percent Change in Resident Population by County: 2000 to 2010

Wyoming Resident Population by County: 2010

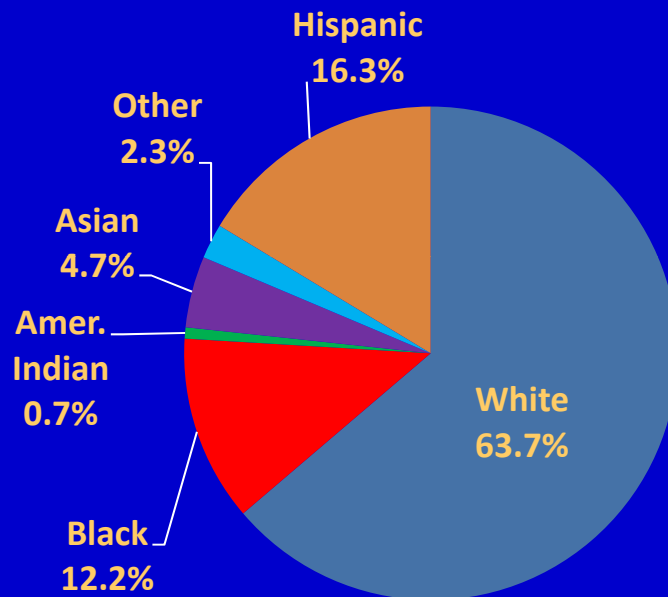

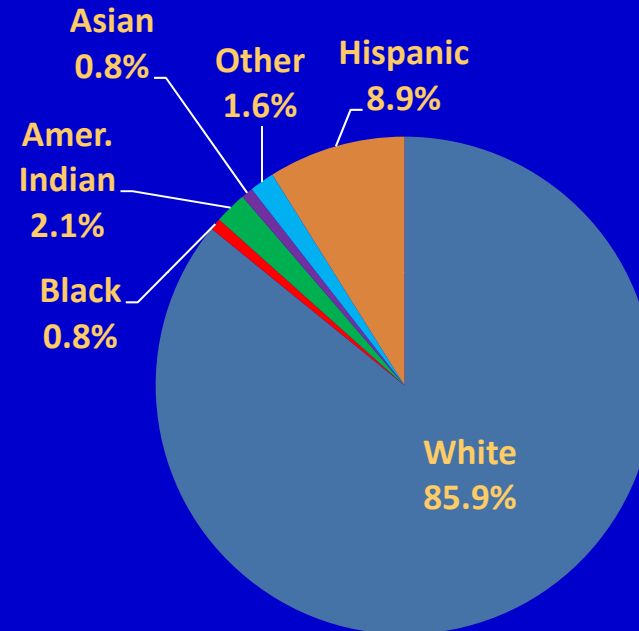

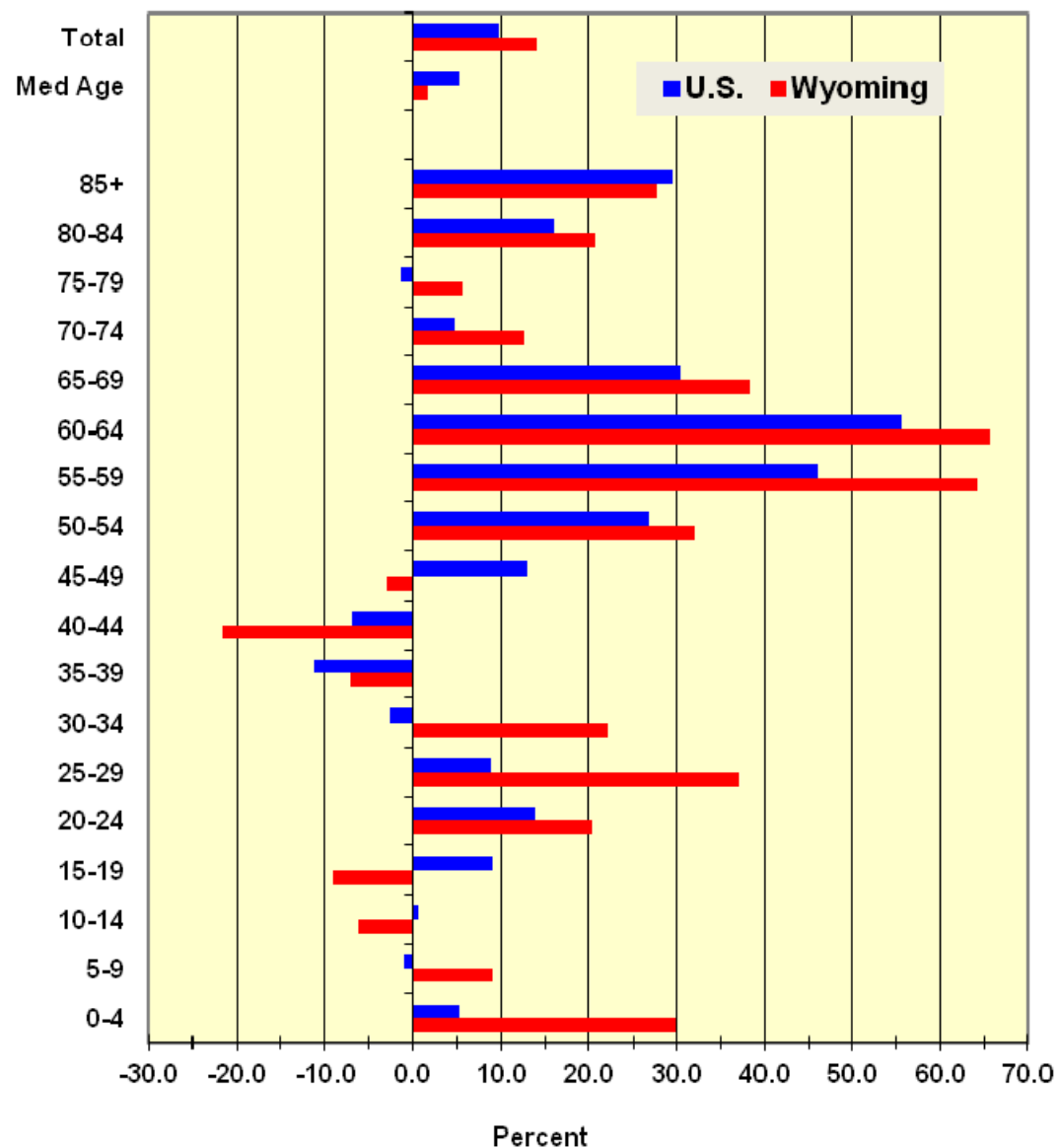

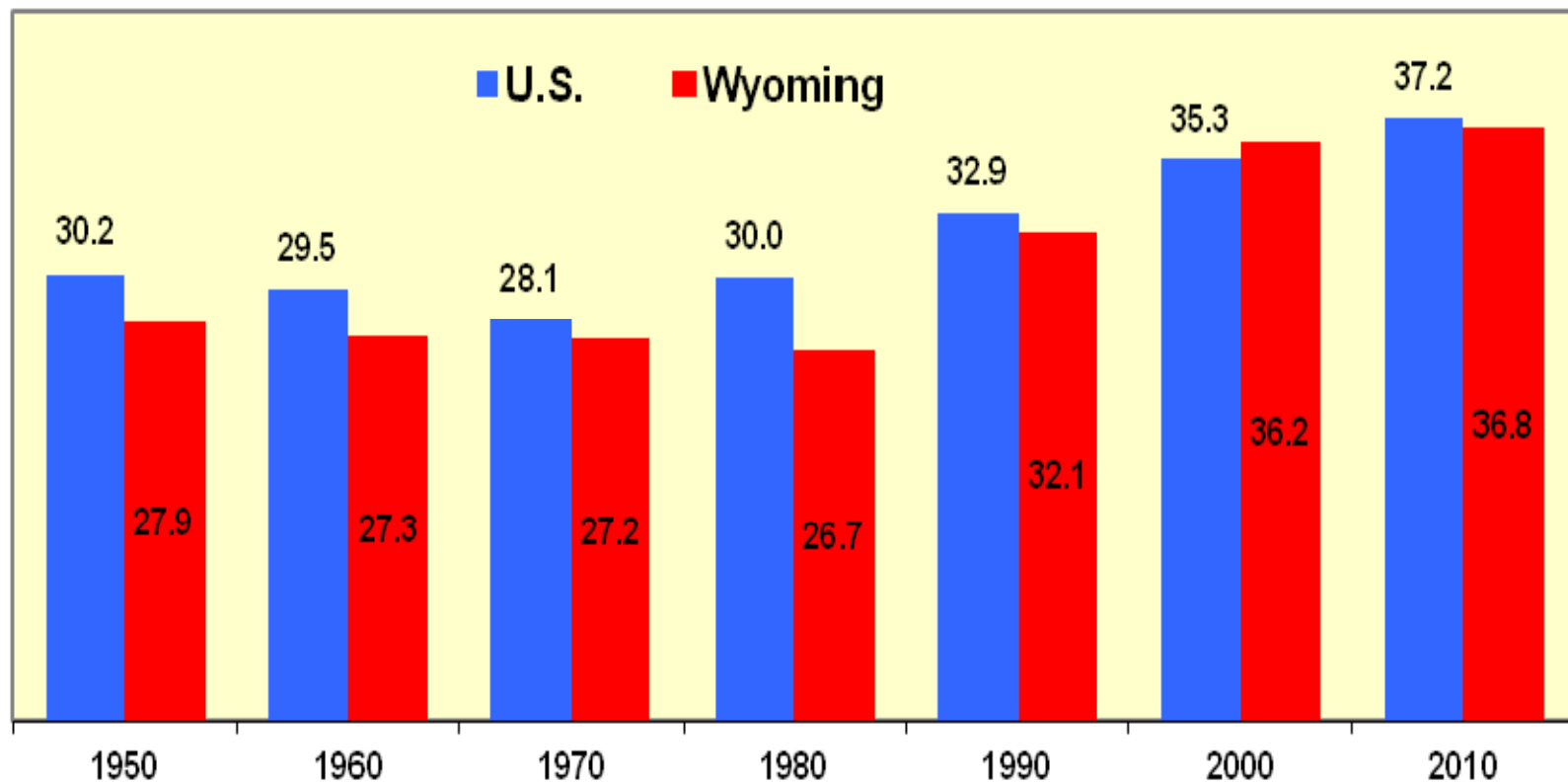

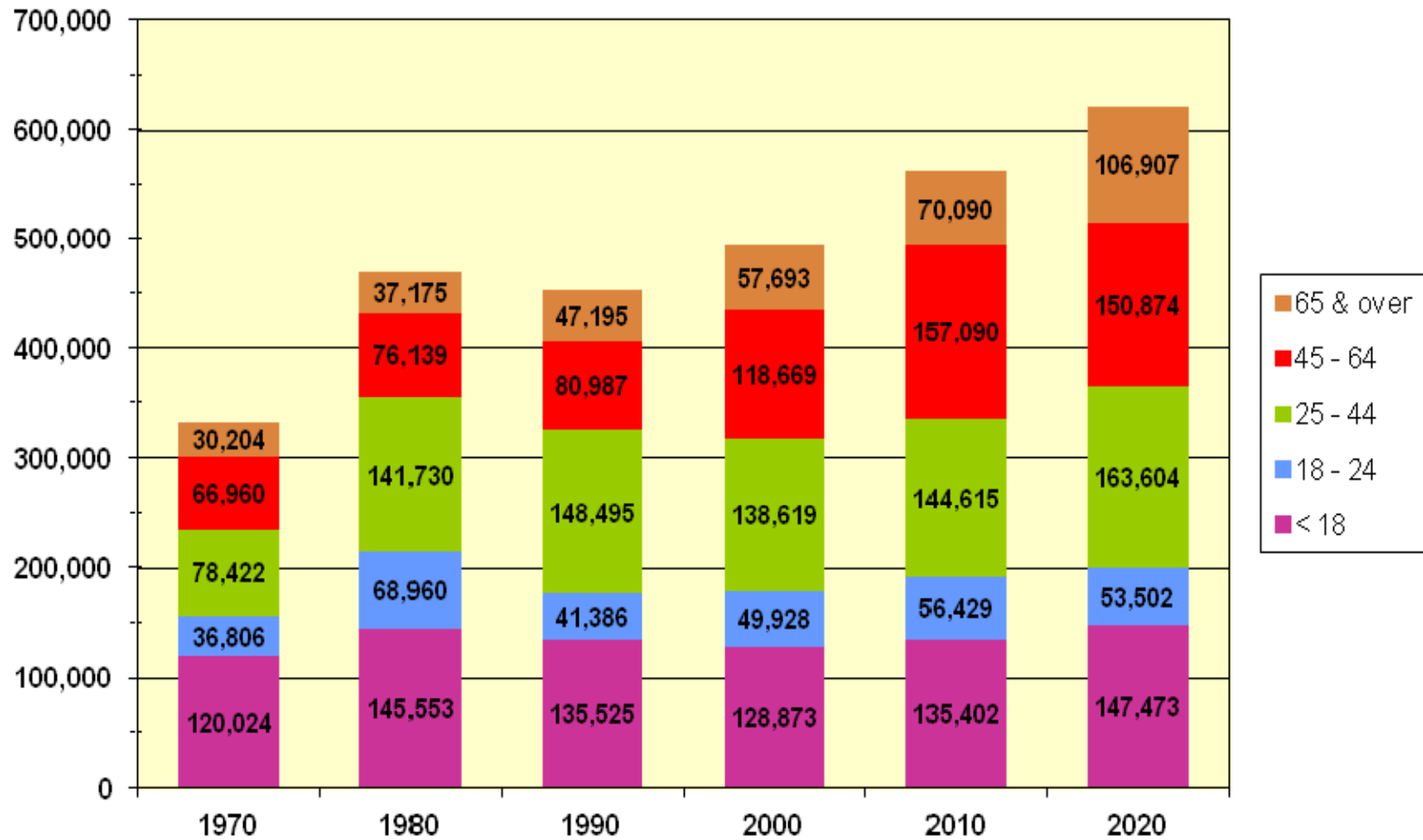
**Percent Change in Population by Age for WY and U.S.
2000 to 2010**



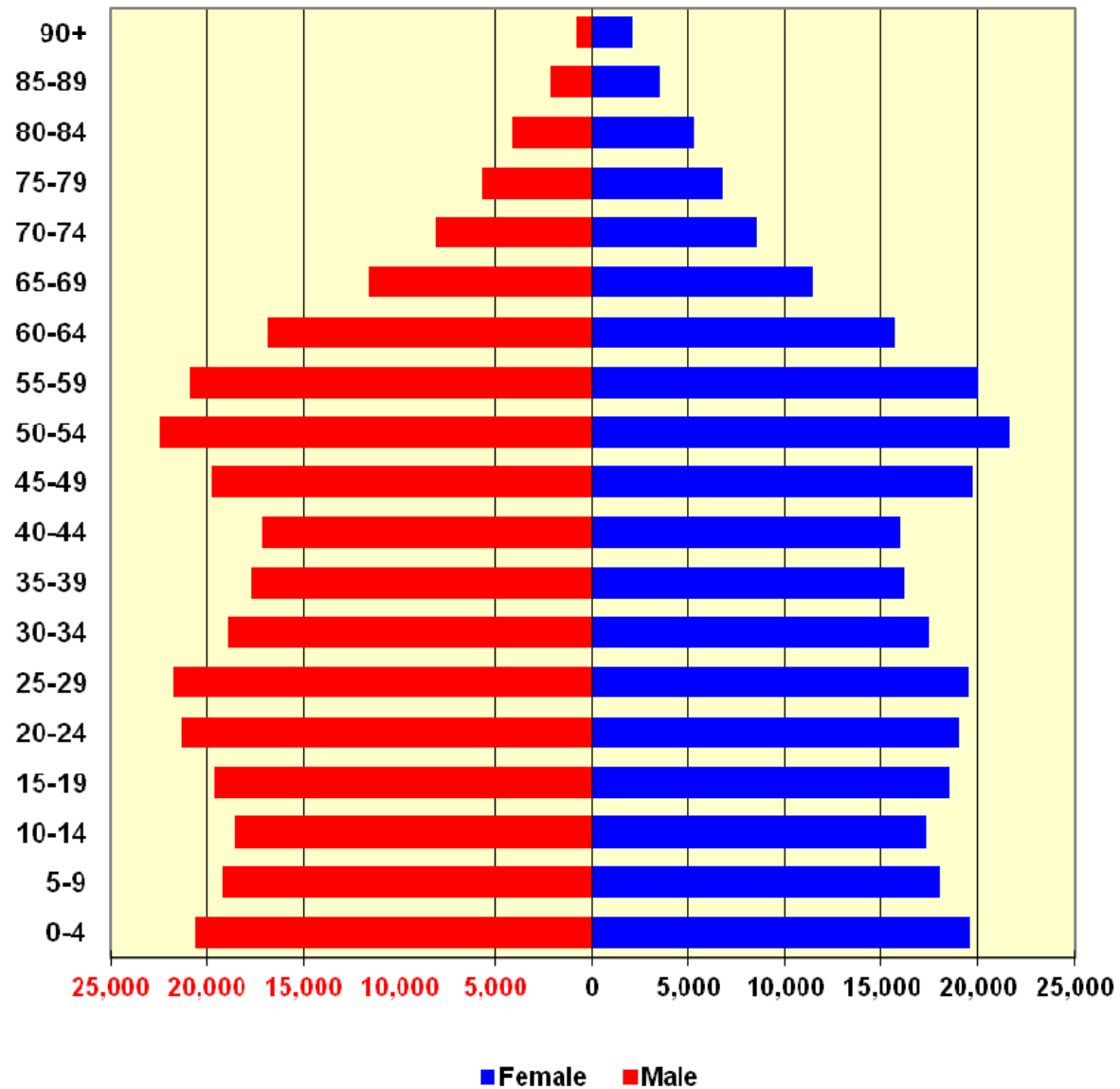

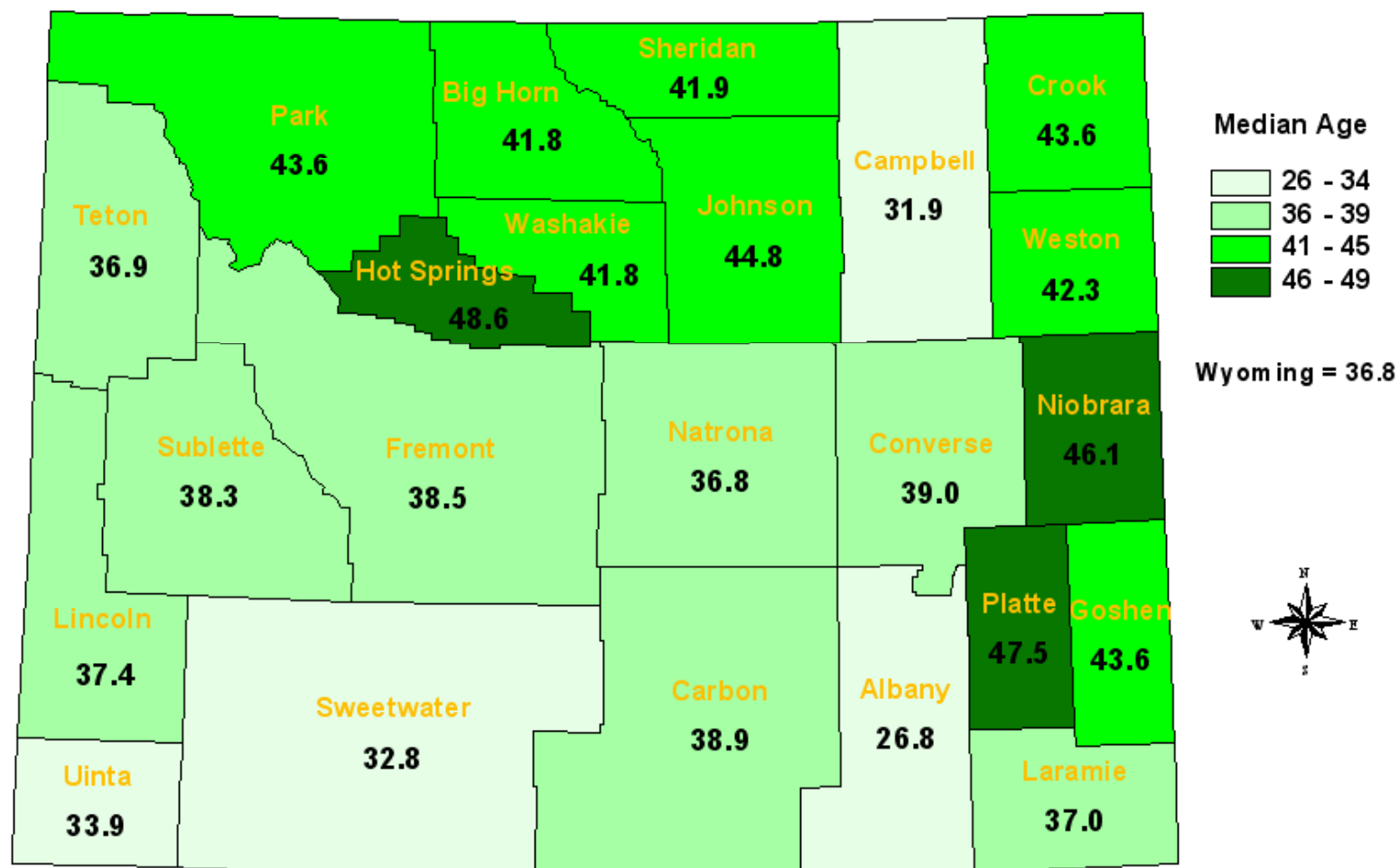
Wyoming Population by Age Group

Population Aging

Speed and pattern are determined by
3 principal factors:

- Most important is the Secular decline in fertility rates
 - sustained increase in the ratio of old to young (<5 vs. 65 & +).
- Mortality rates declined substantially in many countries over the past century (rising life expectancy: Japan=83, US=79)
 - public health, medical tech, standards of living.
- Baby boom in developed countries
 - pronounced rise in post-WWII fertility rates.

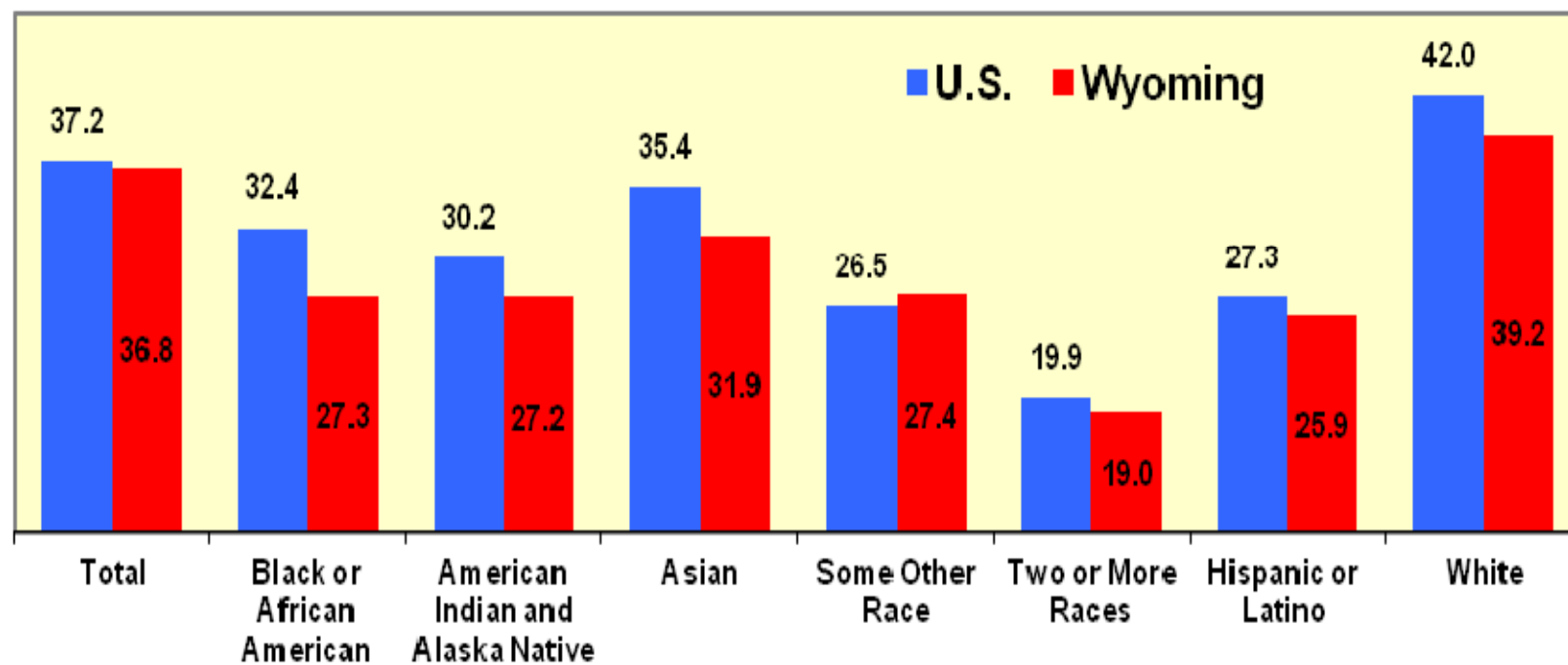
Percent of Population 65 and over:

Japan = 22%; Germany = 20%; Western Europe = 19%. WORLD = 8%.

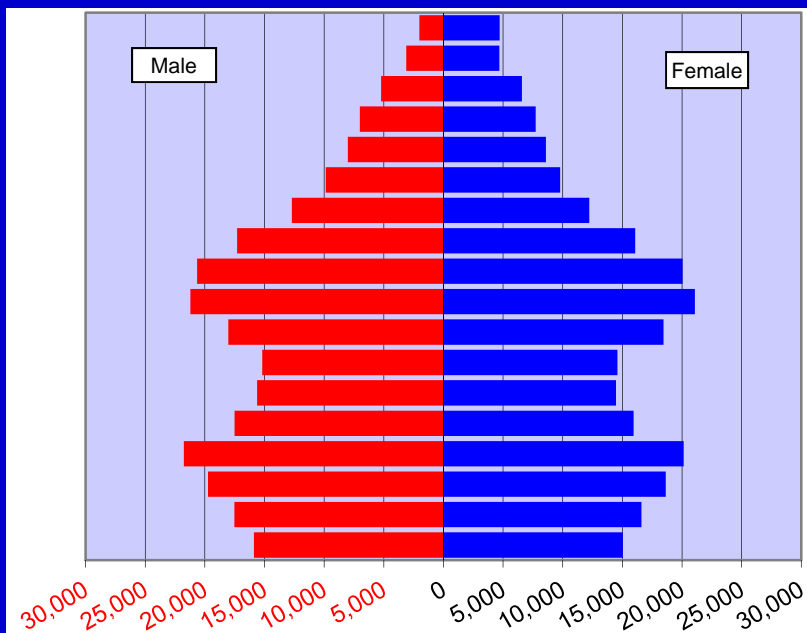
U.S. = 13.0% in 2010, 19.3% in 2030.

Wyoming = 12.4% in 2010, 20.5% in 2030.

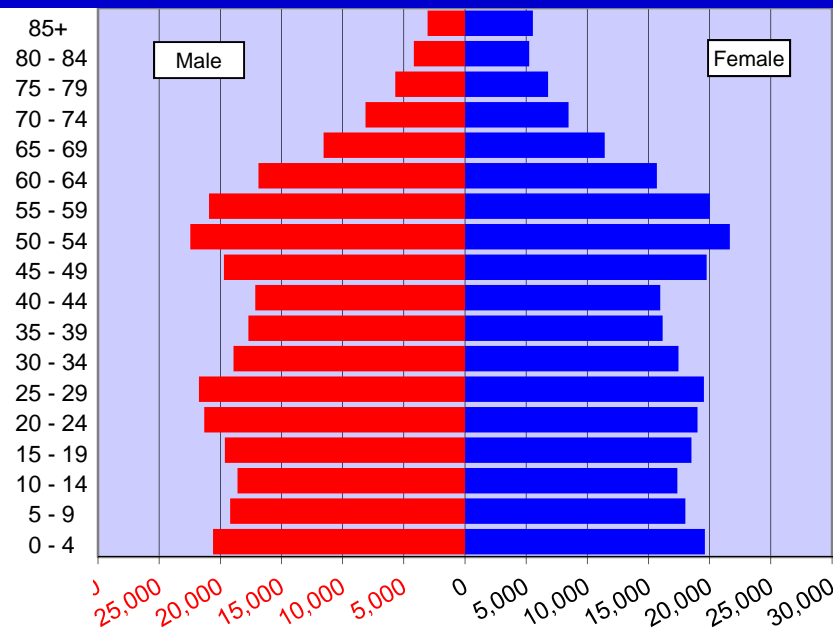
Median Age by Race and Hispanic: 2010



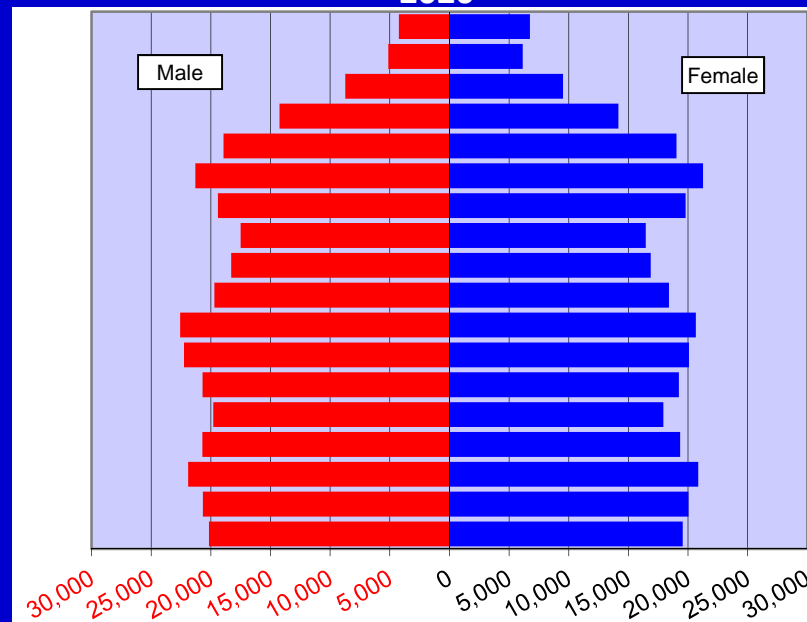

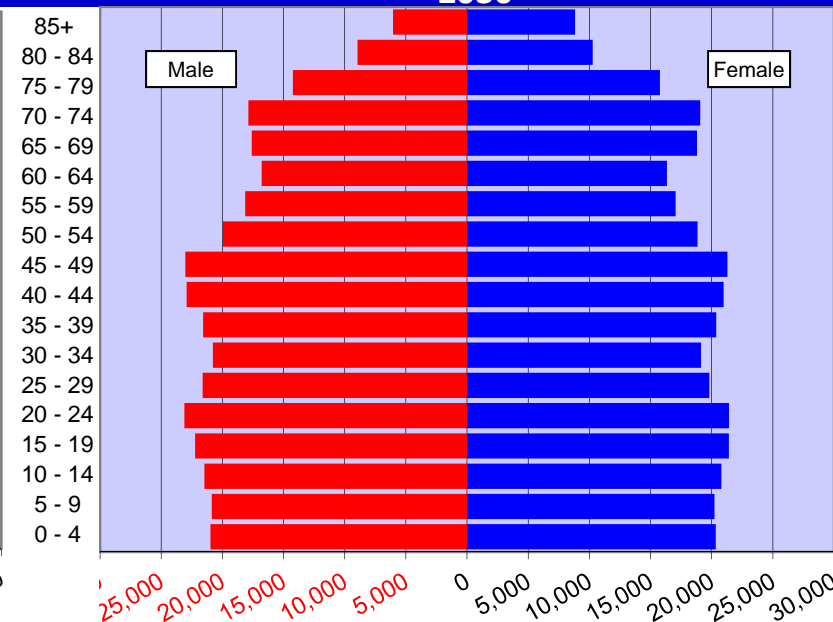

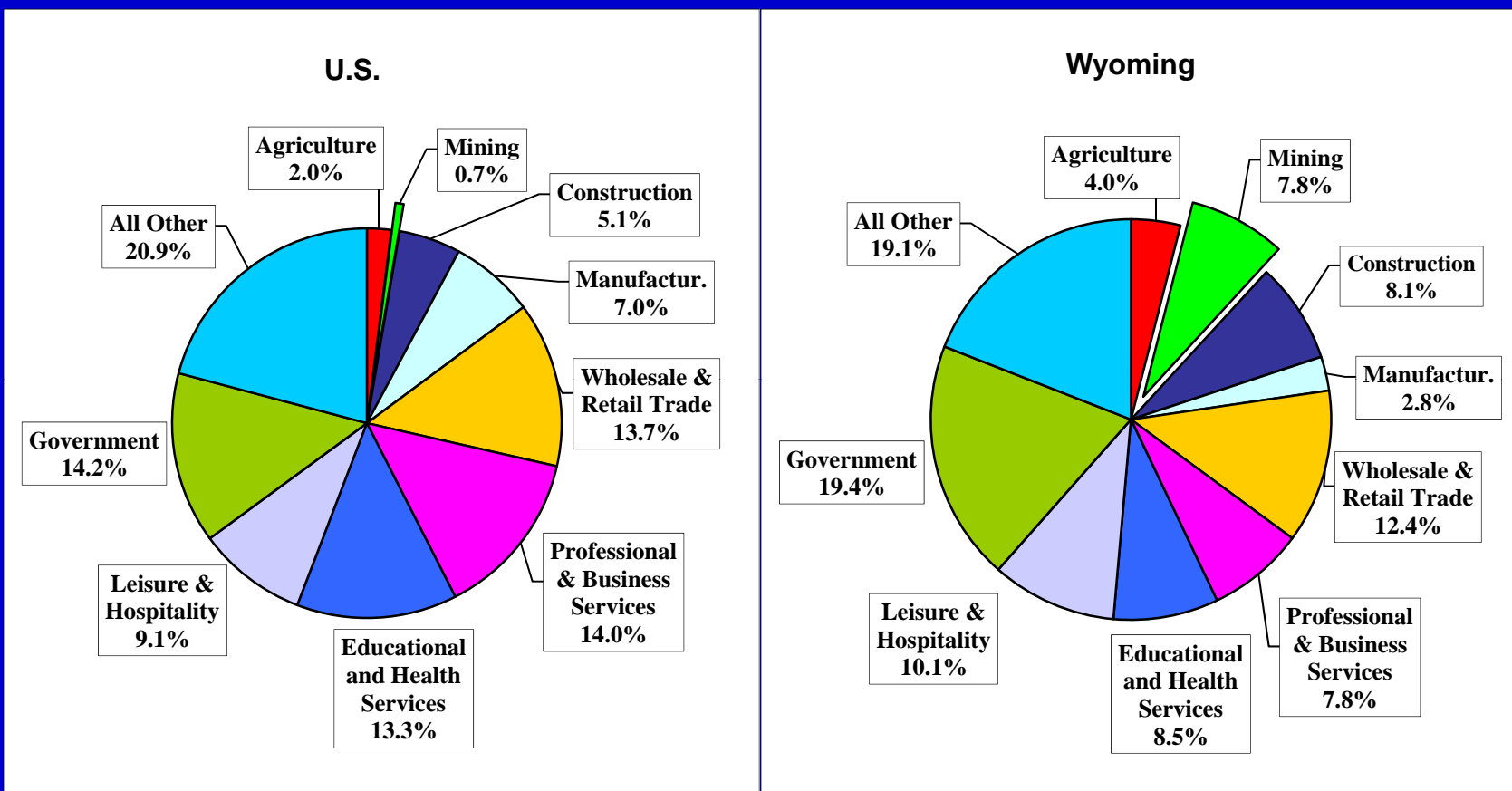

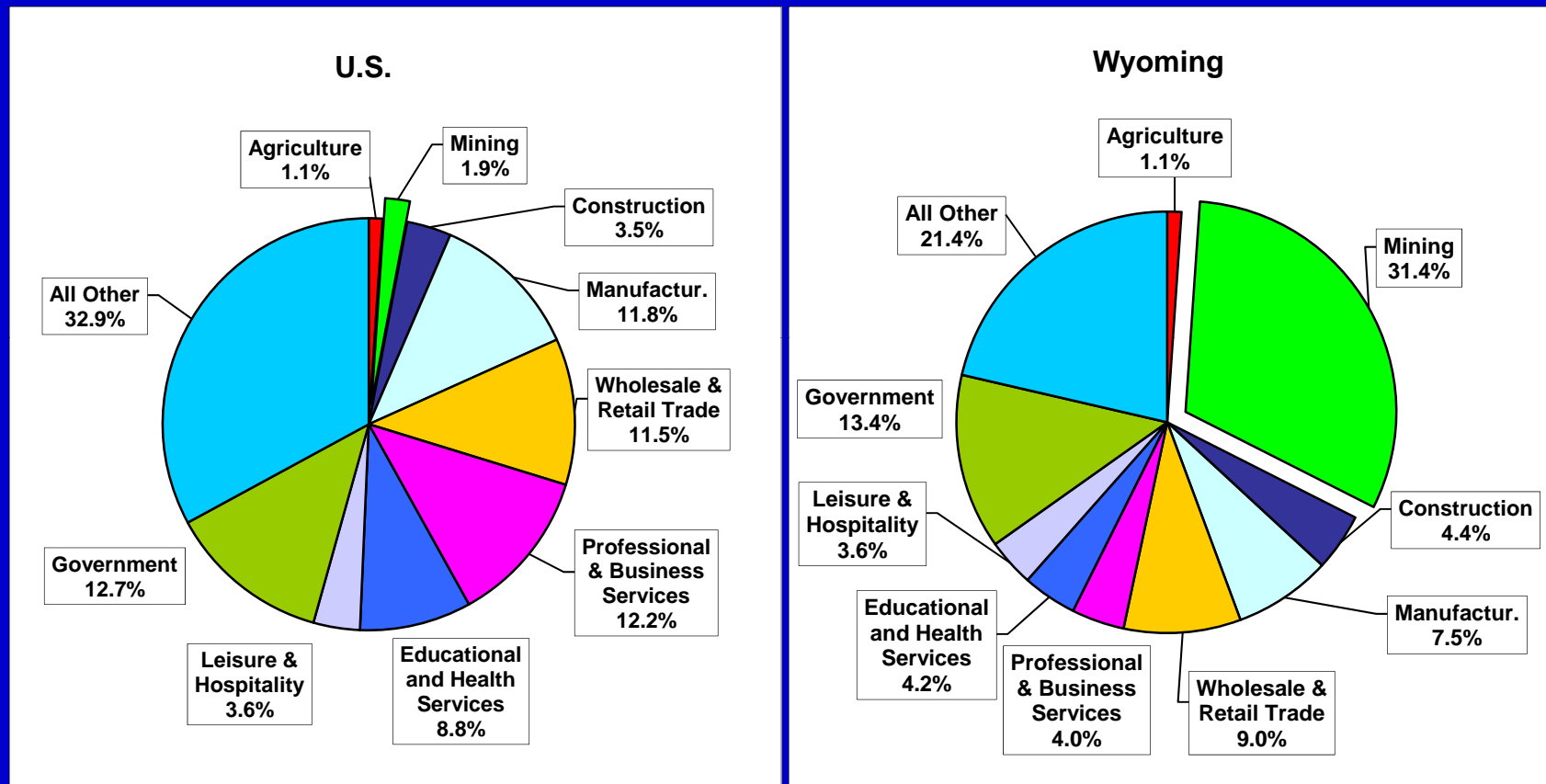

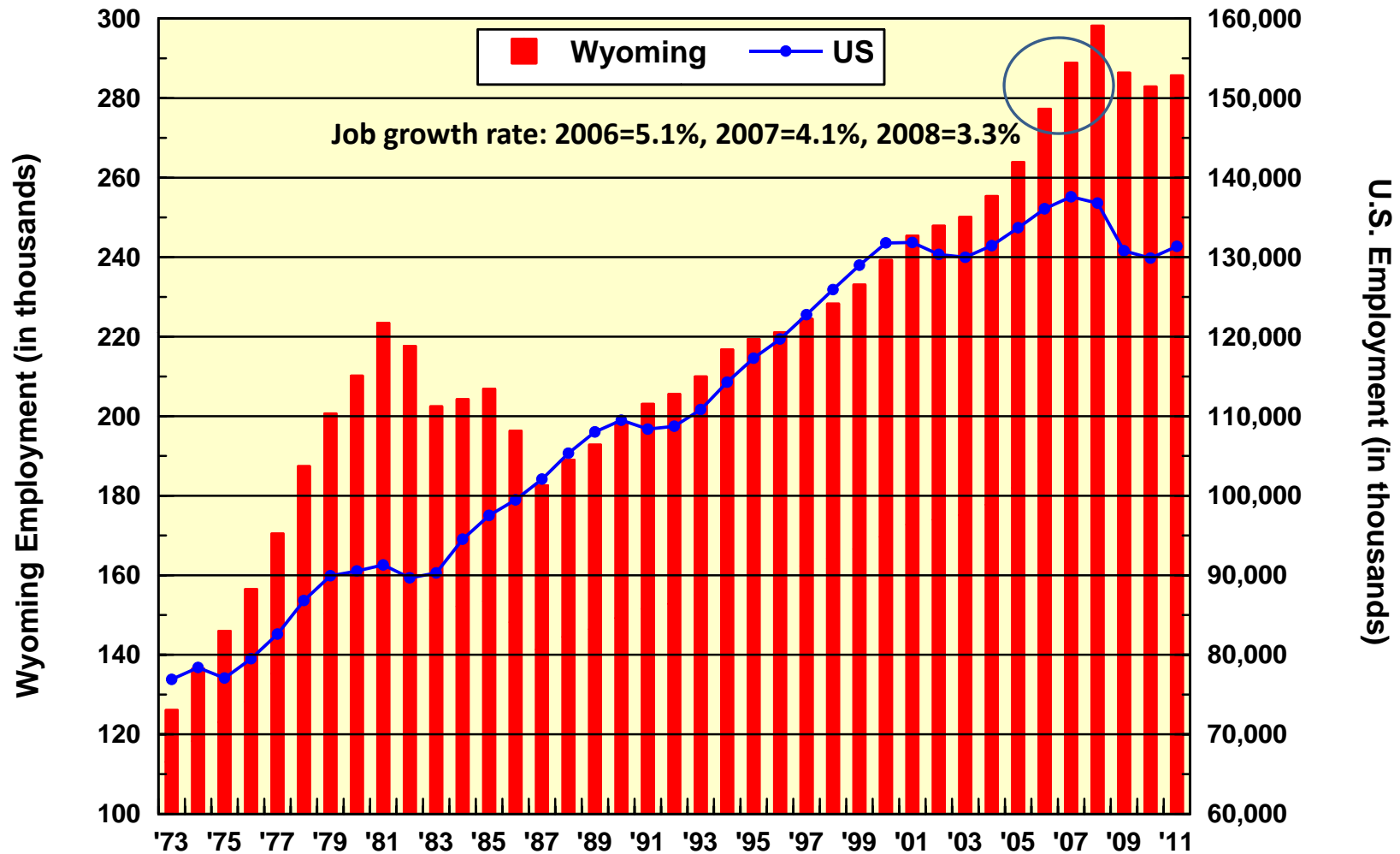
Gross Domestic Product for Wyoming and U.S.: 2010 by Industry

(Number of jobs)

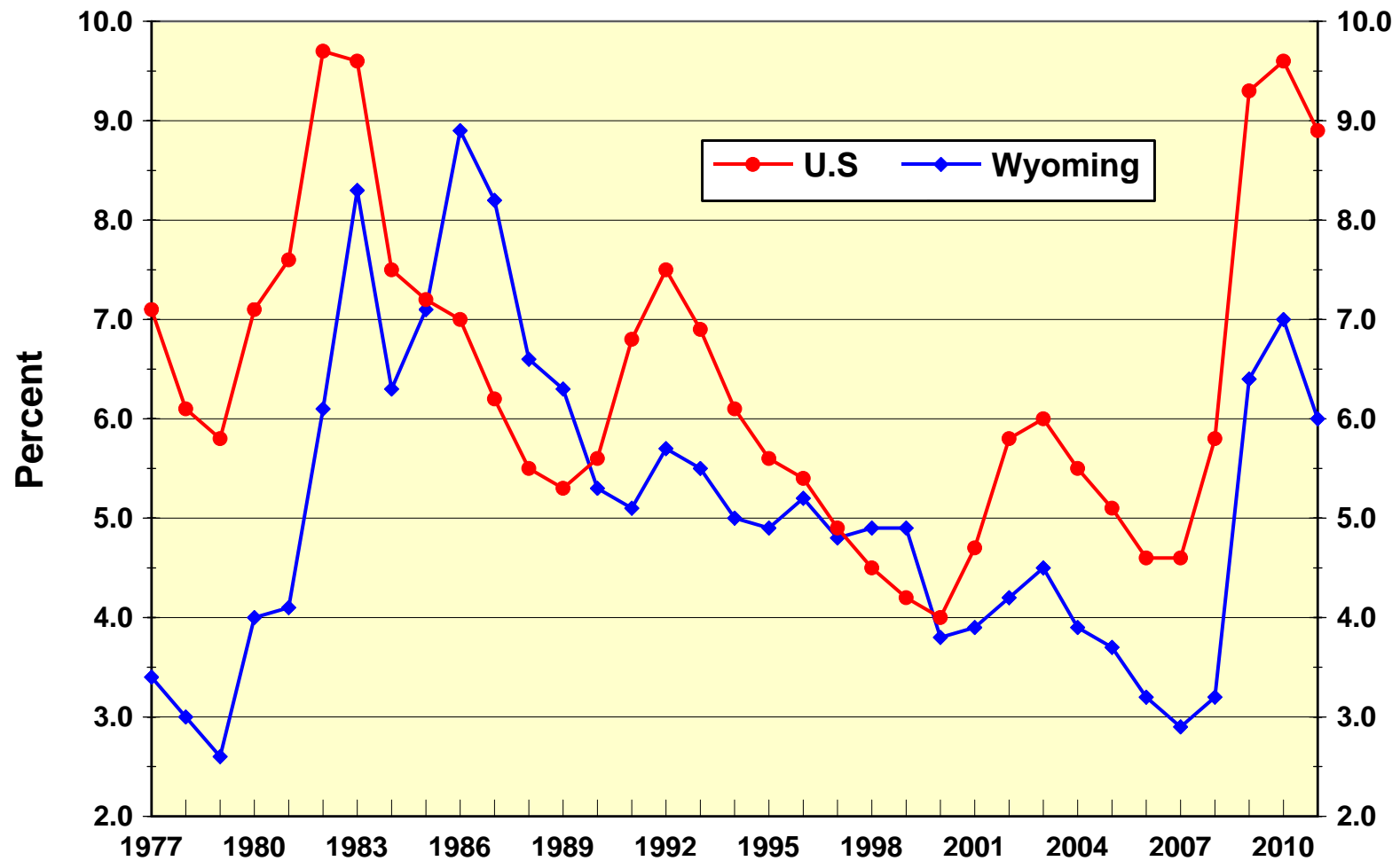

Wyoming and US Unemployment Rates: 1977 - 2011

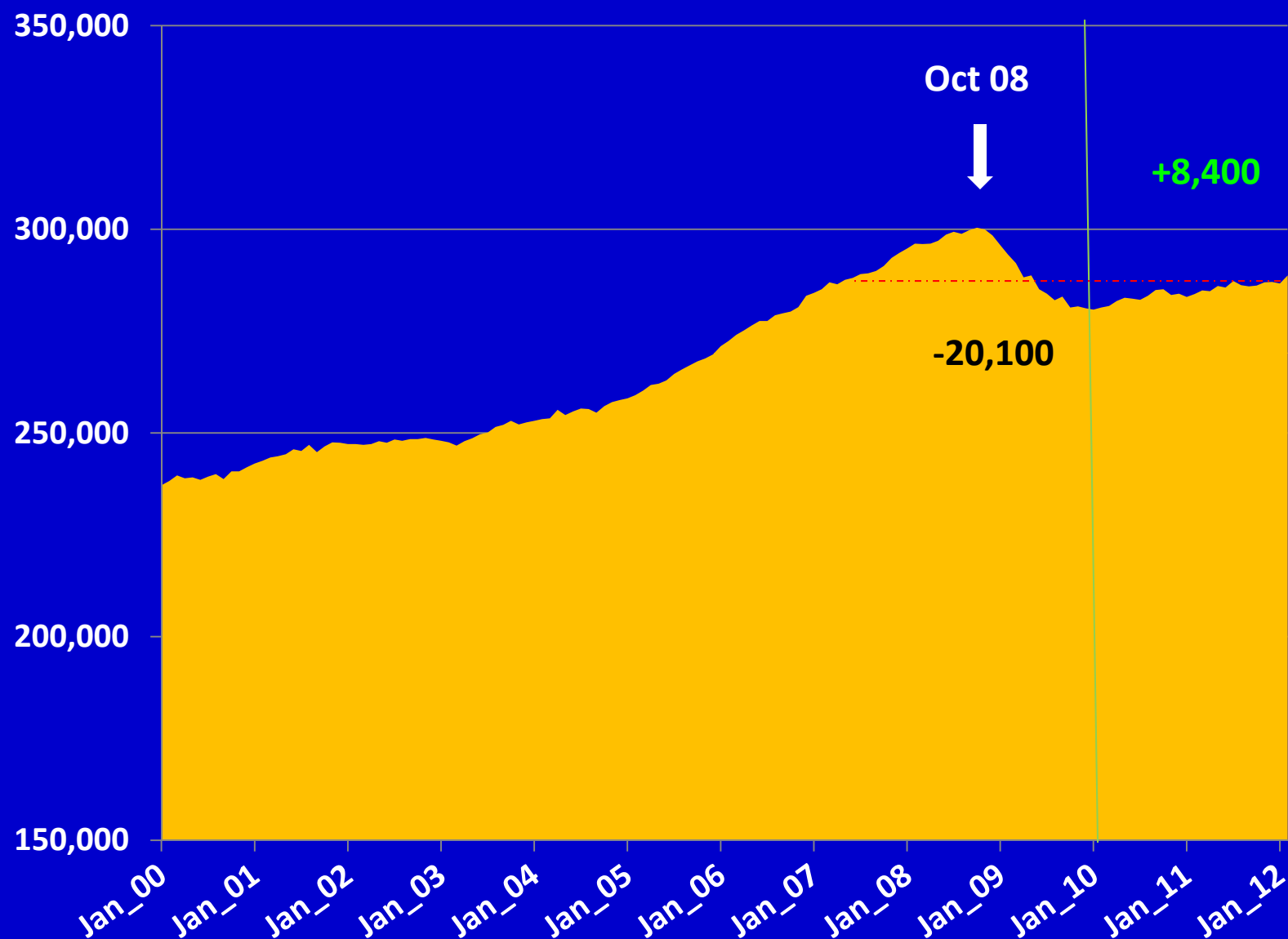

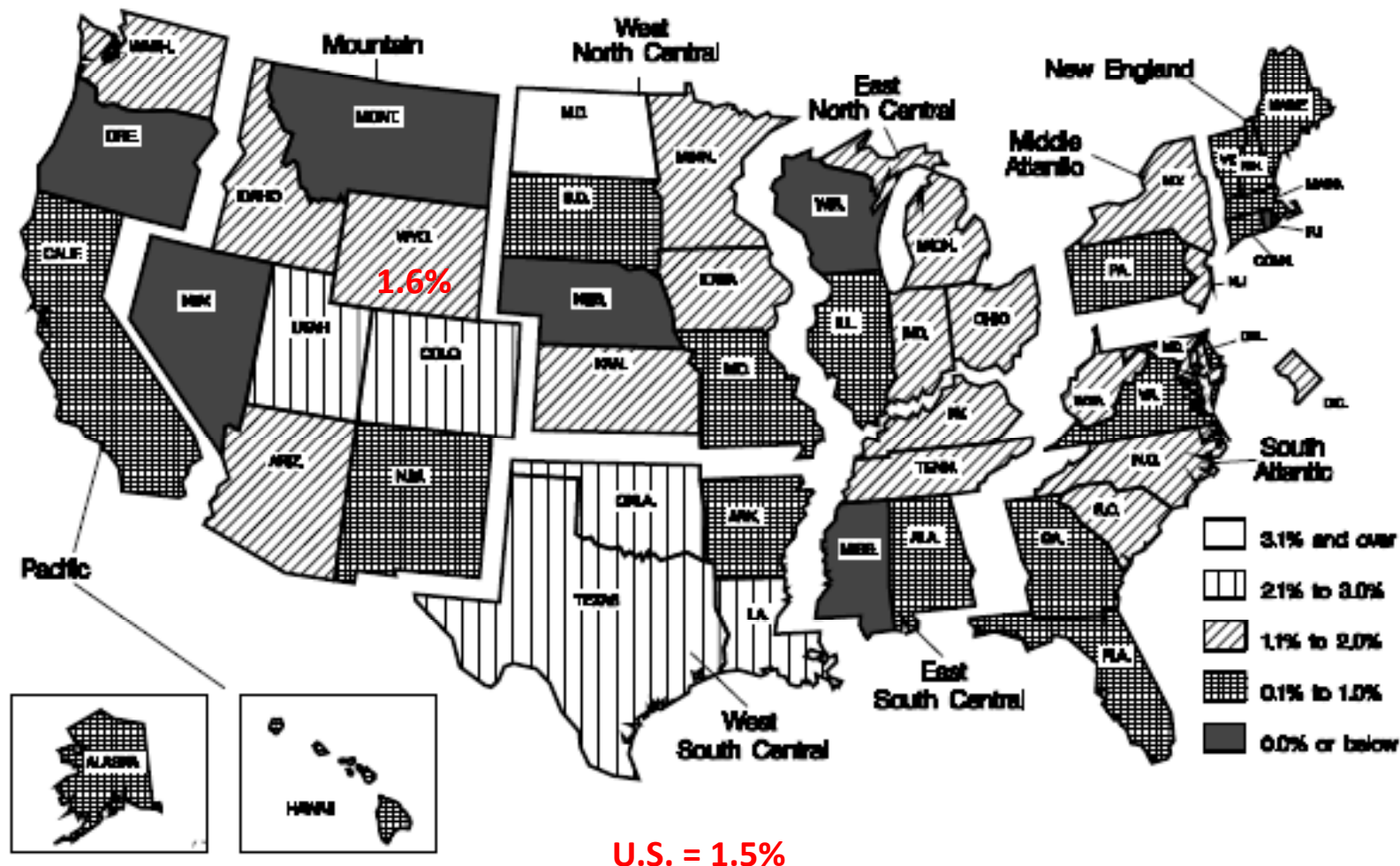

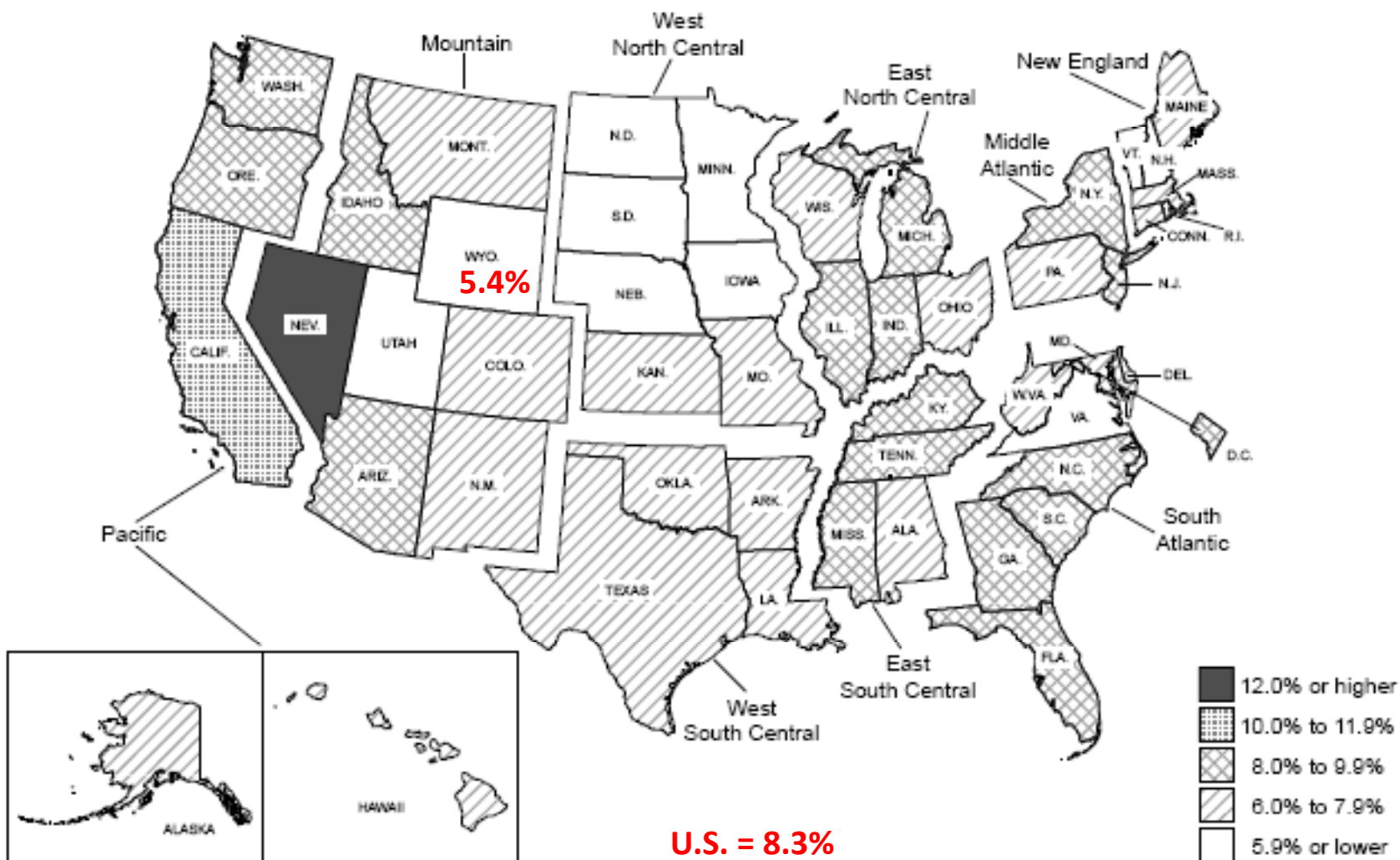
Seasonally Adjusted Monthly Non-Farm Employment

Unemployment Rate by State February 2012 (Seasonally Adjusted)

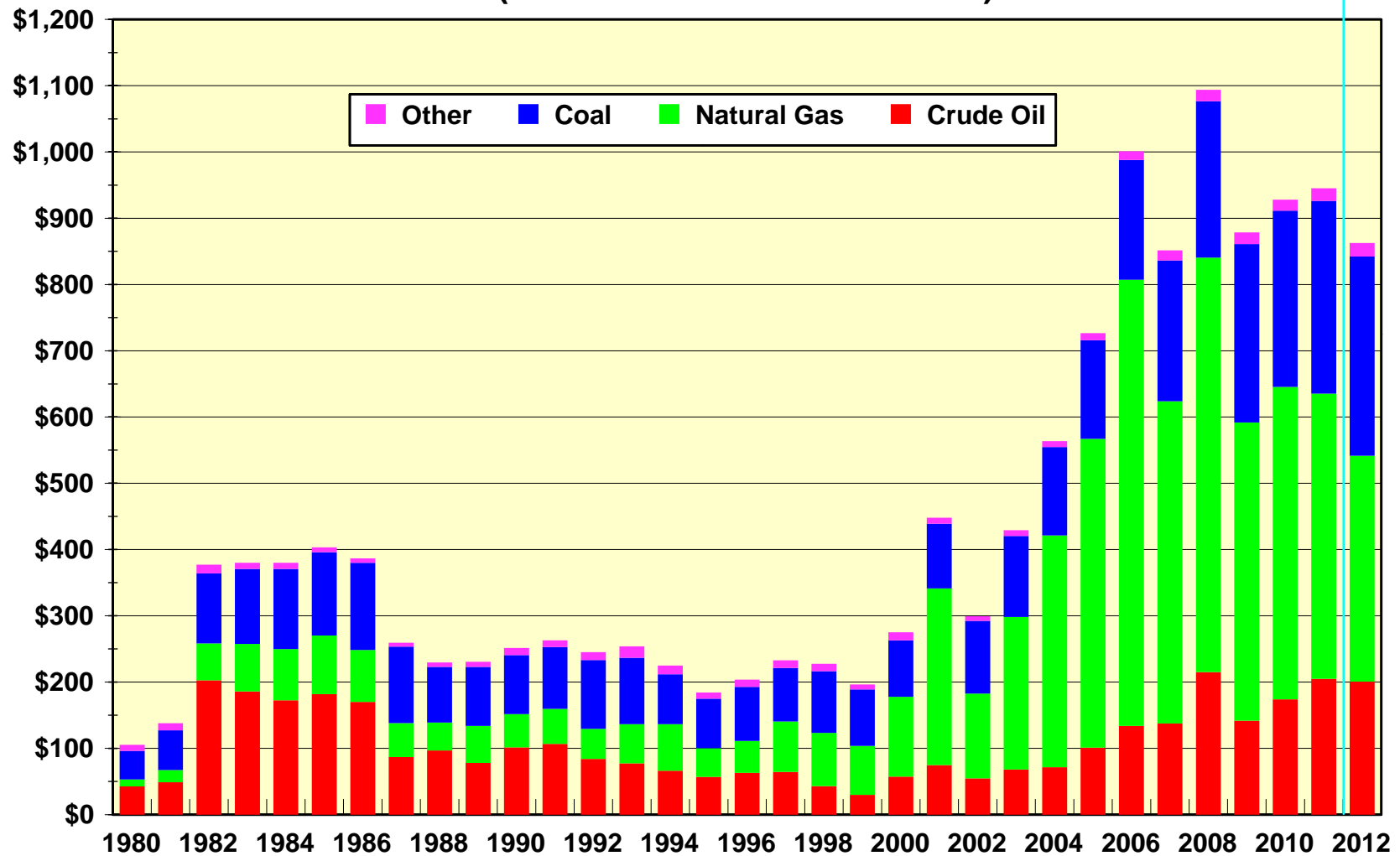


Wyoming Revenue and Tax Facts

- Tax structure reliant on extractive industries.
 - Mineral income currently makes up about two-thirds of State and half of Local Government revenue.
 - FY 2011 Mineral income is obtained from:
 - Mineral severance taxes (\$945.3 million).
 - Federal mineral royalties (\$942.4 million).
 - Mineral property taxes (\$962.1 million).
 - Sales and use taxes (\$167.3 million).
 - Income from PWMTF (\$215.8 million).
- No income tax, low property and sales tax rates (food exemption).
- Near top rank in per capita state and local government revenue and expenditures.
- Household tax burden ranks among the lowest in the nation.
 - Mineral portion is exported out of state.

(in millions of current dollars)

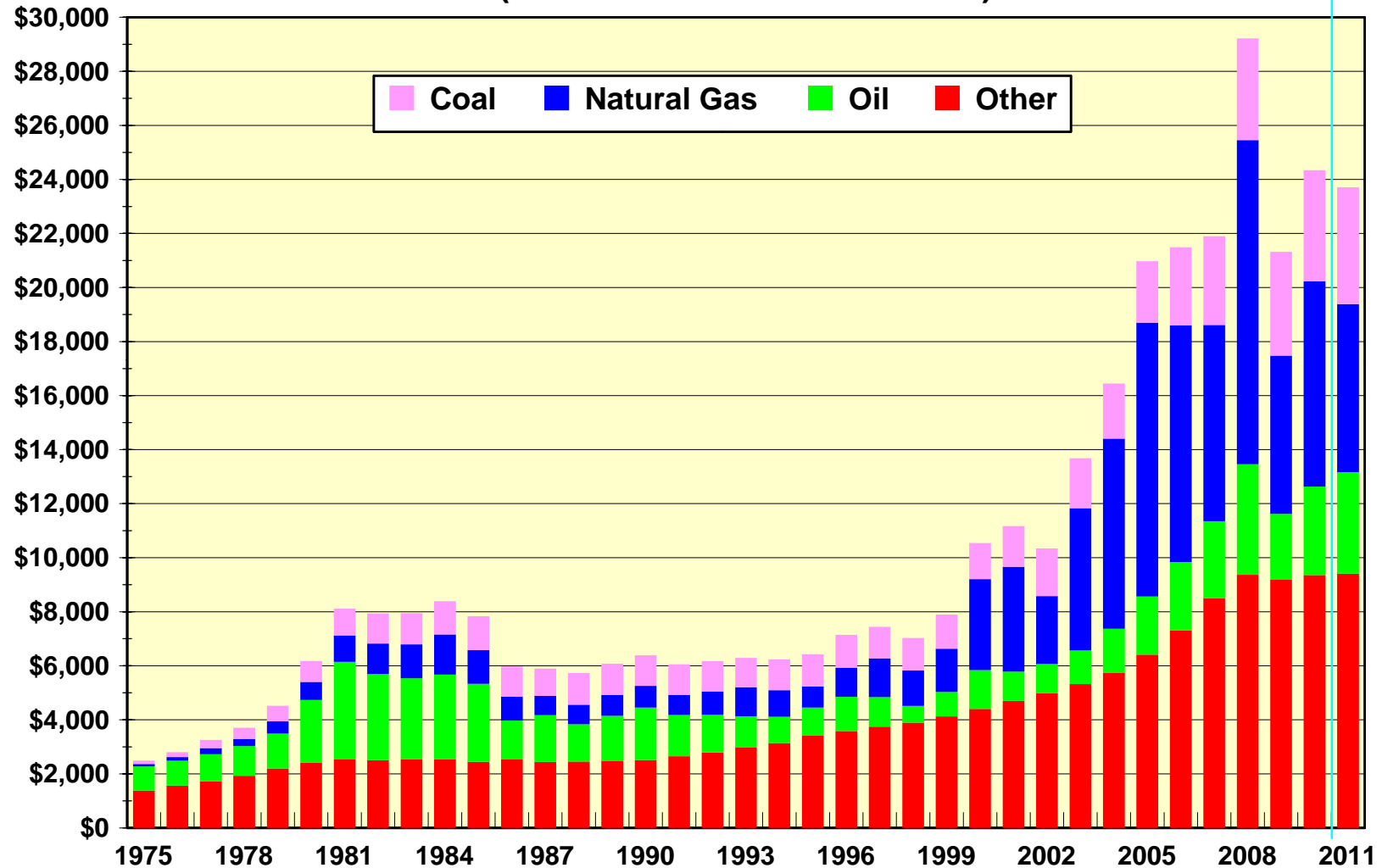

Total Locally and State Assessed Valuation

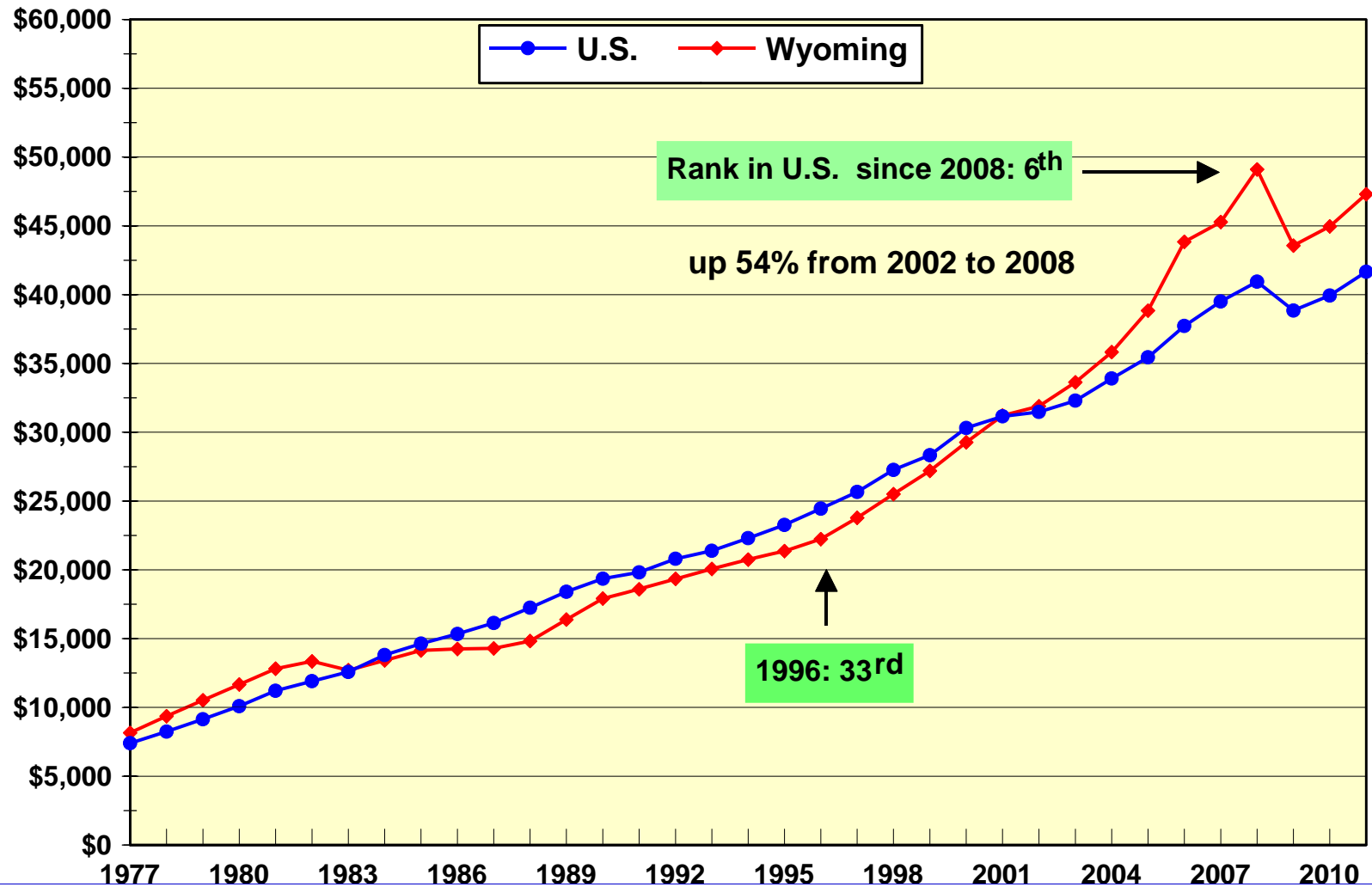

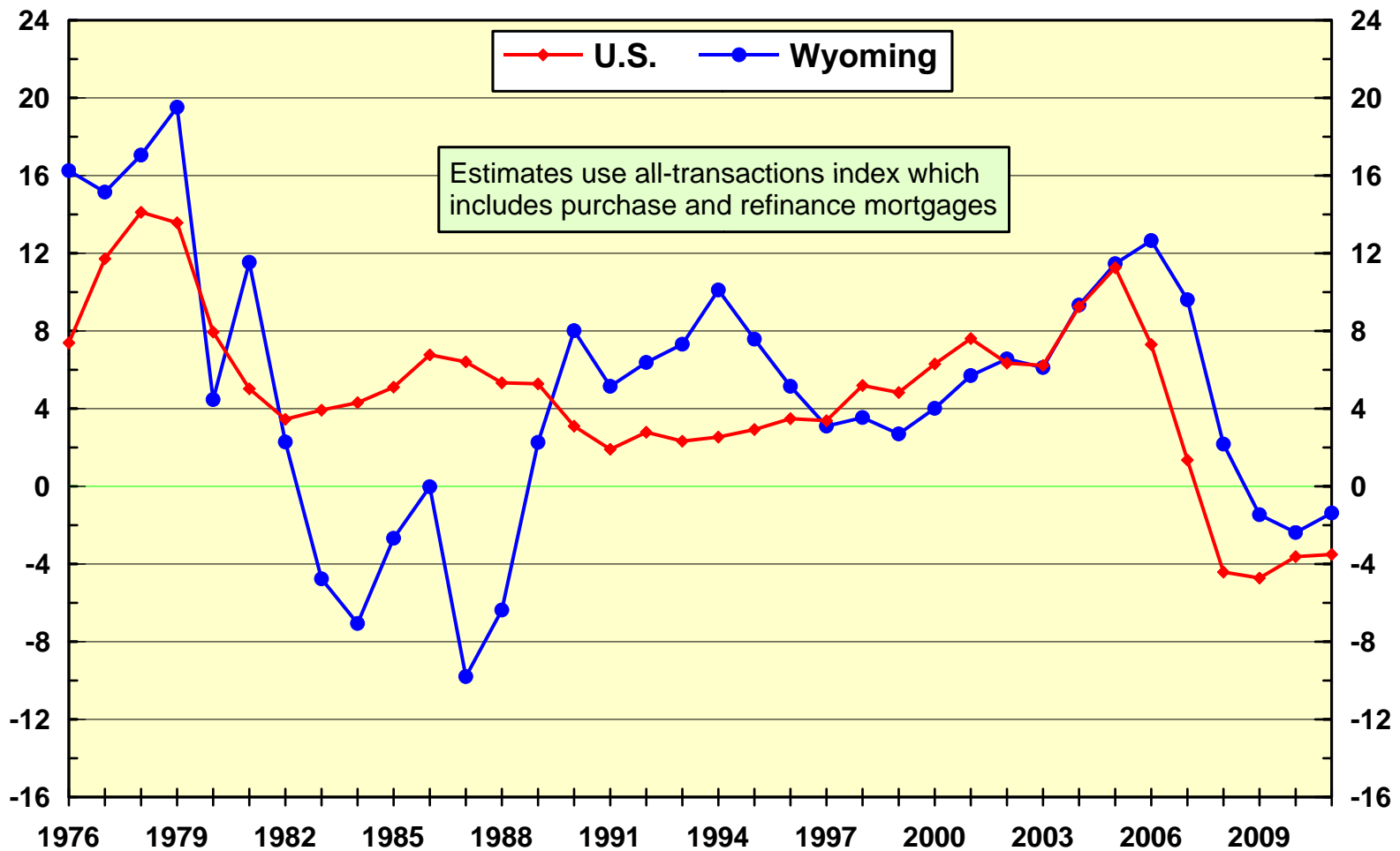

Per Capita Personal Income for US and Wyoming



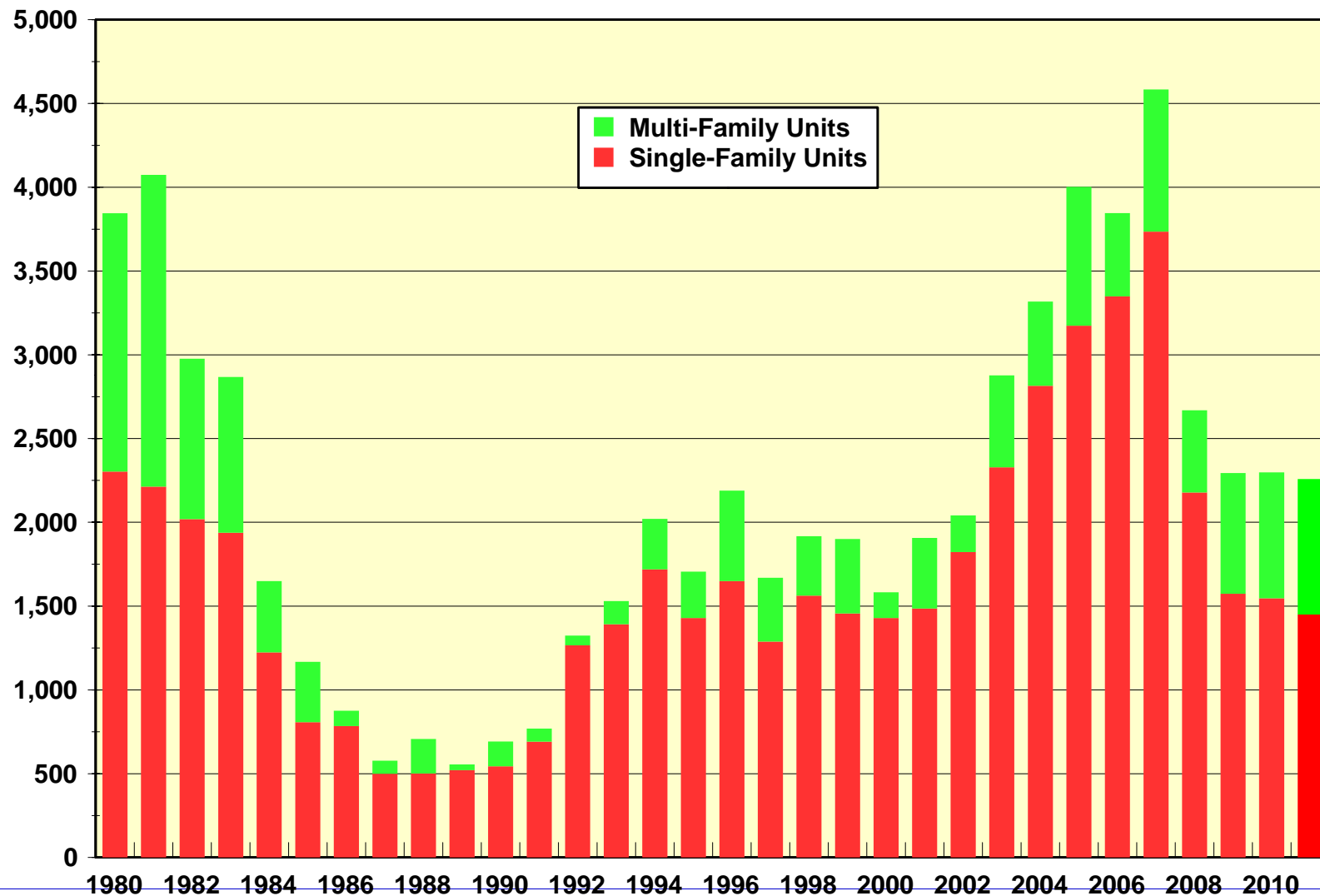

Residential Building Permits Authorized in Wyoming



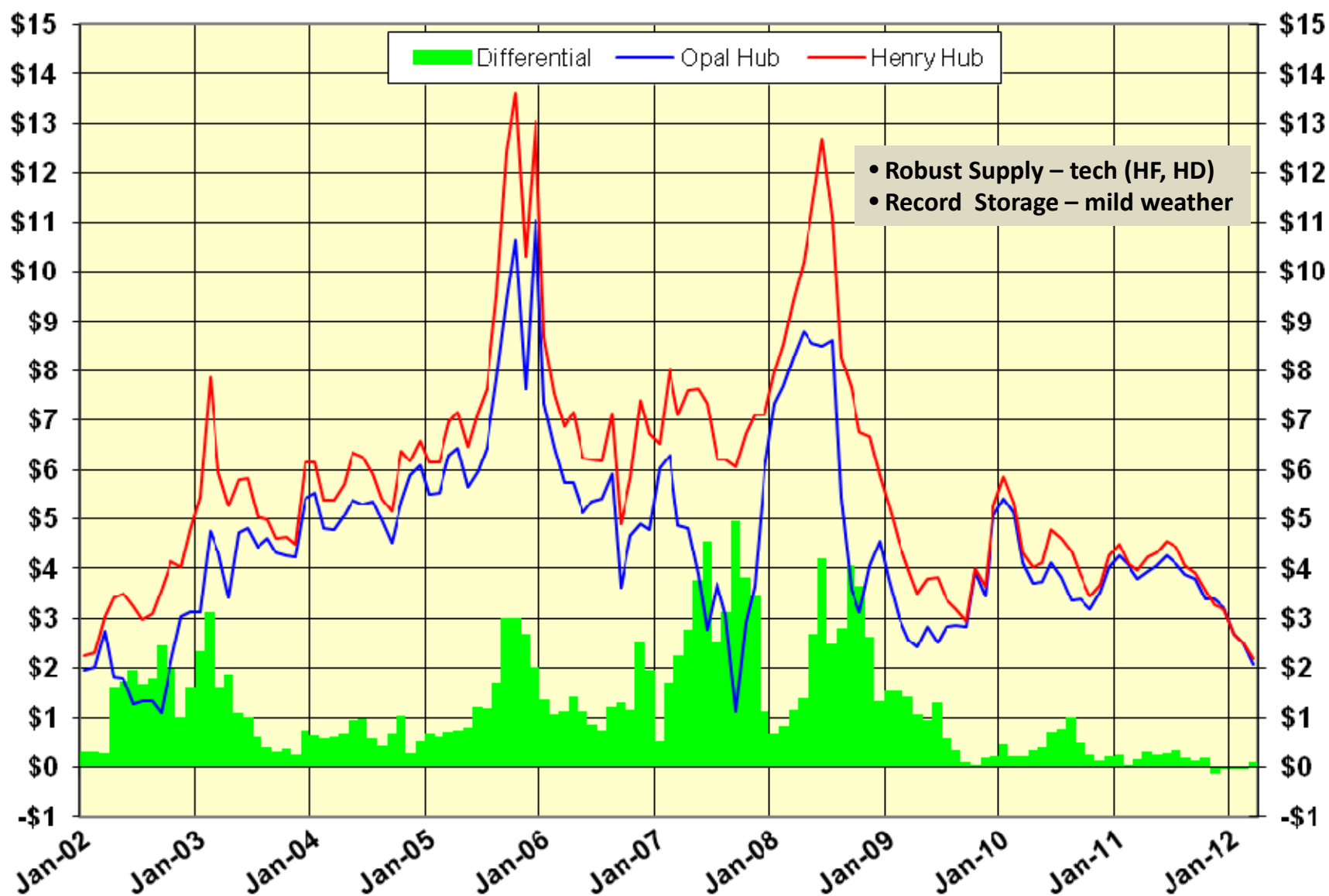

Wyoming's Economic Outlook

- WY economy will continue to improve, though gradually – population grow <1%, and employment will grow about 1.5%; unemployment rate remains around 5%.
 - ✓ global commodity demand and recent U.S. uptrend momentum.
- Expansion of oil development from Niobara Shale, uranium mining from global interest in nuclear power, and development of wind resources.
- The lagging construction industry should have bottomed out.
- Housing market will recover from the mild correction. Stellar wage growth supports consumers spending and residential construction.
- Because of its large proportion and pivotal role in WY's economy, the improvement or deterioration in mining industry will trigger into other economic sections.
- Tourism industry will benefit from national recovery - will bolster tourists' spending ability. Weak dollar supports international visitors.

Negative Factors: persistence of extremely low NG price could impact revenue, coal industry, overall economic recovery to a great extent.
