

PREFACE

The 1996 edition of the Wyoming Sales, Use and Lodging Tax Revenue Report is a compendium of detailed excise tax information. This publication contains sales and use tax collection information by one-digit Standard Industrial Classification (SIC) code. In addition, sales tax collections for the retail sector, itemized by sub-sector component, are provided. Also included in this report, are yearly lodging tax collections by local entity.

This report spans the activity for fiscal years 1985-1996 for sales tax and fiscal years 1991-1996 for use tax collections. Lodging tax information is provided for fiscal years 1990-1996. (The Wyoming State Government fiscal year extends from July 1 through June 30.)

The data were provided by the Wyoming Department of Revenue, and were compiled for publication by the Division of Economic Analysis, Department of Administration and Information, 327 East Emerson Building, Cheyenne, WY 82002-0060, Phone: (307) 777-7504.



INTRODUCTION

Sales and use tax collections are two principal sources of revenue to state and local governments.

However, their importance does not stop there. These two revenue sources, when surveyed over time, provide a valuable indication of economic progress and activity,



both at the state and county levels.

Lodging tax collections provide revenue primarily to cities, towns, and counties. This valuable economic indicator is particularly useful for identifying and monitoring tourism activity and trends.

The reporting of sales and use tax collections is based upon the 1987 Standard Industrial Classification (SIC) code, developed by the Federal Office of Management and Budget. Under this system, a business is classified by primary activity, determined by principal product, or group of products produced, distributed, and/or services rendered. Each sector classification is briefly described in the glossary found on page 101.

SALES TAX

Wyoming has had a sales and use tax since 1935. From 1967 through June of 1993, the state-imposed sales tax rate has been 3 percent. Historically, the revenue from this tax has been shared between state government and local governments within the county of origin at rates of 66.67% and 33.33%, respectively. However, a statute modification that was effective July 1, 1989 through June 30, 1992, reduced the state share to 63.33% and raised the county share to 36.67%. Beginning July 1, 1992, the sales tax distribution was modified again, allocating 65.0% to state government and 35% to the county of origin. This revised allocation remained in effect through June 30, 1993.

On July 1, 1993, the state-imposed sales tax rate was raised to 4 percent and the distribution formula was modified to allocate 72.0% to state government and 28% to the county of origin. By statute, this rate is to remain in effect until June 30, 1998, after which the sales tax rate is to revert back to 3 percent. The distribution rate, however, will not change under the existing statutes.

The State's share of the sales tax revenue is distributed to the General Fund. The significance of this tax is evident in the graph and table shown on pages 1, 5 and 6. The portion returned to the counties and municipalities is distributed based on population.

Beginning in 1973, Wyoming counties were granted the option to impose an additional 1 percent sales tax through public election. During fiscal year 1996, all counties except Fremont, Goshen, Park, Sublette, and Washakie imposed this optional

sales tax. The optional sales tax revenue, less administrative costs, is returned to the county of origin.

In addition to the aforementioned county optional tax, any county, through public election, may impose an additional capital facilities excise tax of up to 1 percent on retail sales made within the county. The revenue generated from this tax is designated solely for the planning, construction, furnishing, equipping, and debt servicing for any capital improvement project as authorized through public election. This tax is referred to as the 1 percent capital facilities option tax. During fiscal year 1996, Albany, Fremont, Goshen, Niobrara, Sheridan, and Teton counties imposed the 1 percent capital facilities option tax, while it has been revoked in Laramie county since January 1, 1996. A table of effective tax rates can be found on pages 7-10.

To arrive at an estimate of county gross sales, the specific county tax collection can be divided by the corresponding tax rate. However, this method suffices as only an approximate indicator of gross sales and does not include any non-taxable sales. (See pages 11-12 for a listing of all taxable events and exemptions.) Further, because county option taxes originate and expire at varying times, county sales tax rates can fluctuate from year to year. When measuring performance over time, the inclusion of these optional revenues results in statistical variance. The table and graph on page 17 displays only the total state imposed sales tax collections, and annual percent change for fiscal years 1985 through 1996.

USE TAX

State use tax is imposed on purchases made outside a taxing jurisdiction for first use, storage, or other consumption within that jurisdiction. Thus, the use tax prevents

sales tax avoidance, or payment of a lesser tax rate by making purchases outside of the taxing jurisdiction where first use, storage, or other consumption will occur. Wyoming taxing jurisdictions are the State of Wyoming, and/or each Wyoming county.

Use tax is a complement of sales tax. Effective January 1, 1981, the adoption of an optional sales tax required a change in the use tax rate of equal amount. State use tax is shared between state government and the county of origin on the same distribution basis as sales tax. Therefore, the revised rate and allocation, as mentioned earlier in the sales tax description, applies here as well. The table and graph on page 79 display only the total state imposed use tax collections and the annual percent change for fiscal years 1985 through 1996.

LODGING TAX

Cities, towns and counties, by voter approval, may impose an excise tax of up to 4 percent on all sleeping accommodations for guests staying less than 30 days. This tax extends to mobile accommodations such as tents, trailers, and campers, as well.

All collections, less a two percent state administrative cost during the first year the tax is imposed, and 1 percent thereafter, are distributed to the cities, towns and counties of origin. At least ninety percent of the tax distributions must be used to promote travel and tourism within the county, city or town imposing the tax. The amount remaining, not to exceed ten percent of the total amount distributed, may be used for general revenue within the governmental entity imposing the tax.

TAXABLE EVENTS AND EXEMPTIONS

Wyoming Statute 39-6-404 describes the following sales and services as taxable events:

1. Retail sales of tangible personal property within the state.
2. Leases of tangible personal property if the property would have been taxable, had it been sold.
3. Intrastate telephone and telegraph services, and the equipment used to carry out such services.
4. Intrastate transportation of passengers.
5. Sales by public utilities and by those furnishing gas, electricity, or heat for domestic, industrial, or commercial consumption.
6. Meals regularly served to the public, and cover charges.
7. Lodging services to transient guests, e.g., motels, hotels.
8. Admissions to amusements, or athletic events.
9. Repair, alteration, or improvement of tangible personal property.
10. Contract seismographic surveying, contract geophysical surveying, and other contract geophysical exploration operations calculated to reveal the existence of geologic conditions favorable to the accumulation of oil or gas, and for all services rendered in and all types of coring, logging, testing, stimulating, perforating, cementing, completing, recompleting, or attempting to complete any well for production of oil or gas.
11. Sales of automobiles, mobile homes, campers, and semi-trailers.
12. Sales of alcoholic beverages.
13. Sales of computer hardware and non-customized computer software.

Wyoming Statute 39-6-402 (a) (iv) defines "Sales Price" as the consideration paid by the purchaser of tangible personal property, excluding the actual trade-in value allowed on property exchanged at the time of transaction, admissions, or services which are subject to taxation as provided by this article, and excluding any taxes imposed by the federal government, or this article.

Wyoming Statute 39-6-405 governs exemptions from state sales tax. Exemptions include the following:


1. Sales of tangible personal property to a person engaged in manufacturing, if such property becomes an ingredient or component of the item manufactured. Sales of containers, labels, etc., are also exempt.
2. Sales of livestock, feeds for feeding livestock for marketing purposes; seeds, roots, bulbs, small plants, and fertilizer, planted or applied to land, the products of which are to be sold.
3. Intrastate transportation of sick, injured, and deceased persons by ambulance or hearse.
4. Intrastate transportation of employees when the transportation is paid for by the employer.
5. Intrastate transportation of raw farm products to processing plants.
6. Interstate transportation of freight and passengers.
7. Sales of energy if the energy is consumed directly in manufacturing, processing, or agriculture.
8. Sales of power or fuel used directly in generating motive power for transportation purposes, provided that gasoline, or diesel fuels used had been taxed (per gallon) under the Special Fuels, or Gasoline Tax Acts.
9. Sales of the services of professional engineers.
10. Sales made to the State of Wyoming, or its political subdivisions.
11. Sales made to a religious, or charitable organization, or non-profit corporations providing meals to senior citizens.
12. Sales of trucks, etc., to holders of a valid I.C.C. permit, provided they are used substantially in interstate commerce.
13. Occasional sales made by religious, or charitable organizations for fund raising purposes.

14. Sales which Wyoming is forbidden to tax, either by the State, or by the laws, or constitution of the United States.
15. Sales of prescription drugs, oxygen for medical use, plasma, prosthetic devices, hearing aids, crutches, wheelchairs, eyeglasses and contact lenses, insulin for human relief, and any syringe, needle, or device for the administration thereof.
16. Leases of vehicle if the lease is computed from gross receipts of the operation, for holders of valid I.C.C. permits.
17. Wholesale sales.
18. Intrastate transportation of freight.
19. Sales of school annuals.
20. Sales of newspapers.
21. Sales to Wyoming joint apprenticeship and training programs.
22. Sales to Joint Powers Boards organized under the Wyoming Joint Powers Act.
23. Transportation of drilling rigs, including charges for loading, unloading, assembly, and disassembly.
24. Sales of food purchased with food stamps.
25. Admission to, or user fees for county, or municipal owned recreation facilities.
26. Sales of carbon dioxide and other gases used in tertiary production.
27. Labor/service charges, including transportation and travel, for repair, alteration, or improvement of property owned by the State of Wyoming, or its political subdivisions.
28. Sales of personal property, or services performed for the repair, alteration, or improvement of railroad rolling stock.
29. Lodging services provided by guides or outfitters.

Fiscal Years 1985 - 1996





SUMMARY OF SALES TAX COLLECTIONS

Total sales tax collections for fiscal year 1996, at \$320.7 million, exceeded the previous level by a margin of 1.5 percent. Collections in 6 of the 10 major industrial sectors were above previous year levels (see Glossary for the explanation of each sector). The finance sector had the largest percentage increase of 25.1 percent, while the mining sector suffered a decline of 8.3 percent. The \$4.8 million increase in total collections was mainly contributed by consumer spending in the retail trade sector which added \$6.4 million in fiscal year 1996. In addition to a \$1.6 million decrease in mining, the public administration sector also recorded a \$1.5 million drop in collections. The collections reported in the public administration sector were primarily comprised of taxes generated through automobile sales.

Annual sales tax collections in 17 of the state's 23 counties increased over previous year levels. Washakie and Fremont county revealed the most considerable increases, at 22.2 and 14.5




6.7 and 6.3 percent respectively. Sixty-six percent of the total increase was in the oil and gas field services of the mining sector for Washakie county, and 78 percent of the total increase was contributed by consumer spending in the retail trade sector for Fremont county. It should be noticed that Laramie county still showed a slight increase of 0.2 percent even though the 1 percent capital facility tax was terminated on January 1, 1996.

Annual sales tax collections decreased substantially from previous year levels in 3 counties: Goshen (-7.0%), Sweetwater (-6.0%), and Sublette (-3.7%). The sectors related to consumer spending (such as retail trade, services, and public administration) and construction contributed to the decline of collections for Goshen county; while the drop in Sweetwater and Sublette counties was, mainly, a result of weak collection in the mining and wholesale trade sectors.

Growth rates for the past twelve years can be found on page 17. Only the 3 percent and 4 percent state sales tax collections (no county optional taxes) were used for this comparison.





* Includes state use taxes plus all local optional and capital facilities use taxes


SUMMARY OF USE TAX COLLECTIONS

Total use tax collections during fiscal year 1996, at \$48.6 million, were up from the year earlier level by 3.1 percent. Four of the 9 major sectors realized increases over fiscal year 1995. Use tax collections usually fluctuate considerably from year to year and from one sector to another.

The only sector which exhibited the most growth in terms of both percentage and dollars was mining. Collections from this sector were up \$2.9 million, or 20.9 percent over the year earlier level. It was the only principal contributor to drive the overall \$1.5 million use tax increase in fiscal year 1996. In addition, this amount of increase in the mining sector more than offset the drop from the mining sector in sales tax collections. Three other growing sectors, agriculture, construction, and manufacturing, showed less than 1

percent increases.

All remaining 5 sectors suffered decreases, with the finance sector having an approximate 54 percent drop from fiscal year 1995. Use tax collections



reported in the public administration sector were primarily comprised of taxes generated through automobile purchases made out of the state.


Annual use tax collections for 12 counties increased over previous year levels. Campbell county revealed the most significant increase, at 46.7 percent over the fiscal year 1995 collection. The \$3.7 million upsurge was due mainly to notable increased activities in coal mining. Crook, Washakie, and Weston counties also realized weighty gains of 30 percent or more over the previous year levels. The bulk of the increase in Crook and Weston resulted from heightened operations in railroad transportation, while the durable goods in the wholesale trade sector presented principal growth for Washakie county.

Other significant increases were realized in Natrona (9.6%) and Sheridan (8.2%) counties. The increase in total use tax collections for Natrona county resulted from new coal mining related activities. Sheridan county's increase stemmed primarily from increased telephone communication services within the transportation sector.

Use tax collections declined from year earlier levels in 11 counties. Niobrara county realized a decline of 66.1 percent from the year earlier level, after a tremendous upsurge of 693 percent from fiscal year 1994 to 1995. This lag stemmed from a sharp decline in railroad transportation activities. Other counties that realized substantial declines in use tax collections were Fremont (-32.0%), Platte (-23.0%), and Uinta (-21.3%).

Growth rates for use tax collections over the past twelve years can be found on page 79. Only the 3 percent and 4 percent state use tax collections (no county optional taxes) were used for this comparison.



SUMMARY OF LODGING TAX COLLECTIONS

Total lodging tax collections for fiscal year 1996 was \$2.6 million, a decrease of 32.2 percent from \$3.8 million collected in the previous year. Apparently, this dive was caused by the reversion of the 2 percent lodging tax in Teton county and 1 percent in Pinedale town of Sublette county as of July 1, 1995. When these two counties are excluded, the remaining collections were up by 2 percent from fiscal year 1995 to 1996. Lincoln, Washakie, and Albany counties demonstrated significant increases of 12.6, 10.2, and 9.4 percent, respectively. The expansion of nearly \$23,000, or 6.5 percent, in Park county probably indicates the continuation of economic growth of the tourism industry in the national park areas.

Overall, increases over fiscal year 1995 levels were realized in 13 of the 23 counties statewide. Big Horn, Campbell, Carbon, Fremont, Platte counties endured over 3 percent drop from the prior year levels. Since the lodging tax option in many instances is limited to municipal coverage alone and not imposed county-wide, certain county comparisons are not possible.

AGRICULTURE

This division includes establishments primarily engaged in agricultural production, forestry, commercial fishing, hunting and trapping, and related services. (p. 21)

APPAREL

This major group includes retail stores primarily engaged in selling new clothing, shoes, hats, underwear, and related articles for personal wear and adornment. Furriers and custom tailors carrying stocks of materials are also included. (p. 323)

AUTOMOBILE

This major group includes retail dealers selling new and used automobiles, boats, recreational vehicles, utility trailers, and motorcycles including mopeds; those selling new automobile parts and accessories; and gasoline service stations. In Wyoming, these collections **do not** include sales of new and used vehicles, since the County Treasurer collects this tax; therefore, they are included in the public administration sector. (p. 265)

BUILDING AND HARDWARE

This major group includes retail establishments primarily engaged in selling lumber and other building materials, paint, glass, wallpaper, hardware, nursery stock, lawn and garden supplies, and mobile homes. (p. 315)

CAPITAL IMPROVEMENT TAX (Sec. 39-6-412, W.S. 1984)

This is an optional sales tax imposed for the express purpose of capital construction. The revenue from the tax shall be used only for planning, construction, furnishing, equipping, and debt service for any capital improvement project authorized by public election.

CONSTRUCTION

This division includes establishments primarily engaged in construction. The term construction includes new work, additions, alterations, reconstruction, installations, and repairs. (p. 53)

FINANCE

This division includes establishments operating primarily in the fields of finance, insurance, and real estate. (p. 335)

FOOD STORES

This major group includes retail stores primarily engaged in selling food for home preparation and consumption. (p. 319)

FURNITURE

This major group includes retail stores selling goods used for furnishing the home, such as furniture, floor coverings, draperies, glass and chinaware, domestic stoves, refrigerators, and other household electrical and gas appliances. (p. 325)

GENERAL MERCHANDISE

This major group includes retail outlets such as department stores, variety stores, and general merchandise stores which sell a number of lines of merchandise such as dry goods, apparel, accessories, furniture and home furnishings, small wares, hardware, and food. (p. 317)

INHERITANCE TAX (Sec. 39-6-810 to 39-6-813, W.S. 1977)

This new provision repealed the old state Inheritance Tax. The state now collects all or its pro rata share of the "Federal Credit for State Death Tax". This tax is applicable to the estates of descendants whose date of death is January 1, 1983 and thereafter. This tax is commonly referred to as a "pickup tax", wherein the state of domicile, and the states where the non-resident descendant owned real and tangible personal property with an actual situs in the non-domiciliary state, collect the Federal Credit or a pro rata share which is allowable on the Federal Estate Tax Return.

LODGING TAX (Sec. 39-6-412, W.S. 1977)

Cities, towns and counties, by voter approval, may impose an excise tax of up to 4 percent on all sleeping accommodations for guests staying less than 30 days. This tax extends to mobile accommodations such as tents, trailers, and campers, as well. Guides and outfitters are exempt.

MANUFACTURING

The manufacturing division includes all establishments such as plants, factories, and mills engaged in the mechanical or chemical transformation of materials or substances into new products. (p. 67)

MINERAL SEVERANCE TAX (Section 39-6-301 to 39-6-307, W.S. 1977)

The tax is levied on the cash market value of specified minerals and valuable deposits after the mining or production process is completed. The particular rate varies with the type of deposit. The distribution of collections to the State funds (General, Trust and Agency, Capital Facilities, etc.) also varies with the type of deposit.

MINING

This division includes all establishments primarily engaged in mining. Mining is used in the broad sense to include the extraction of solid and gaseous minerals occurring naturally, as well as other preparation customarily done at the mine site, or as a part of mining activity. (p. 39)

MISCELLANEOUS STORES

This major group includes retail establishments not elsewhere classified such as drug stores, liquor stores, and used merchandise stores. (p. 329)

PUBLIC ADMINISTRATION

This division includes the executive, legislative, judicial, administrative, and regulatory activities of Federal, state, local, and international governments. (p. 407)

RESTAURANTS

This major group includes retail establishments selling prepared foods and drinks for consumption on the premises, and also lunch counters and refreshment stands selling prepared foods and drinks for immediate consumption. (p. 329)

RETAIL TRADE

This division includes establishments engaged in selling merchandise for personal or household consumption and rendering services incidental to the sale of the goods. (p. 313)

SALES TAX (Sec. 39-6-401 to 39-6-417, W.S. 1977)

This tax is levied on the gross receipts from the sale of tangible personal property and specified services. The collections are distributed between the State General Fund and local jurisdictions. For a listing of rates and exemptions, refer to the tables on pages 7-9 and 10-11, respectively, in this report.

SERVICES

This division includes establishments primarily engaged in providing a wide variety of services (i.e. legal, health, and repair) for individuals, business and government establishments, and other organizations. (p. 353)

TRANSPORTATION (TCPU)

This division includes establishments providing to the general public or to other business enterprises, passenger and freight transportation, communication services, electricity, gas, steam, water or sanitary services, and the U.S. Postal Service. (p.265)

USE TAX (Sec. 39-6-501 to 39-6-603, W.S. 1977)

The Use Tax is levied upon tangible personal property that is purchased from an out-of-state vendor and shipped directly to the purchaser for storage, use, or consumption in the state. Freight and property in interstate transportation is exempted. For a listing of rates and exemptions, refer to the tables on pages 7-9 and 10-11, respectively, in this report. Collections are distributed between the State General Fund and local jurisdictions.

WHOLESALE TRADE

This division includes establishments or places of business primarily engaged in selling merchandise to retailers; to industrial, commercial, institutional, farm, construction contractors, or professional business users; or to other wholesalers; or acting as agents or brokers in buying merchandise for or selling merchandise to such persons or companies.
