WYOMING COST OF LIVING FOR THE FOURTH QUARTER 2009

The **Economic Analysis Division** has completed the Wyoming Cost of Living Index (WCLI) for the fourth quarter of 2009. The WCLI is a summarization of price data collected in twenty-eight cities and towns throughout Wyoming over the period of January 6, 7, and 8, 2010. The price data collected are used to build a comparative index and to estimate inflation rates for Wyoming and the five regions of the State.

Twenty-eight communities across the State were included in the WCLI based on the following criteria. First, the largest city or town in each county was priced. In addition, prices were collected in any city or town with a population of more than 5,000 persons or where a city or town had at least 85% of that county's largest community's population. In counties where only one community was priced, those prices were used to represent the entire county. In counties where two communities were priced, a population based weighted average of the prices for the two communities was used for the entire county. Also, starting with the second quarter 2003 WCLI report, Afton in Lincoln County was added through legislative action and was included in the comparative index. Kemmerer is still priced. Afton and Kemmerer report separate comparative index numbers. Beginning with the second quarter of 2004, Afton in Lincoln County was included in the inflation calculations.

The 140 items surveyed were aggregated into six categories, which were then weighted according to their overall importance in the average consumer's budget. These categories and their respective weight components include Housing (49.3%), Transportation (15.3%), Food (14.6%), Recreation & Personal Care (9.5%), Medical (6.4%), and Apparel (4.8%)¹. The Housing category, due to its relative importance in the average consumer's budget, carries the largest weight factor and is the most influential category in both the comparative index and the inflation rates.

COMPARATIVE INDEX

The comparative index is found in **Table I**. It compares each county's price level to the statewide average for the fourth quarter of 2009. All twenty-three counties are included in the comparative index. Movement in ranking from a previous survey does not indicate that the price level has increased or decreased in a particular county. Instead, this table reflects only the price level of each county, *at the time of data collection*, compared with the statewide average of 100.

Wyoming entered the fourth quarter of 2009 still feeling the effects of the Great Recession that has severely impacted the global economy. The winter of 2009 also saw the national economy enter a slow and nearly jobless recovery. "Even though Wyoming was still lagging the national economy in emerging from the recession, unemployment in the State did not reach the double digit levels experienced by the nation during the worst part of the downturn," observed Justin Ballard, senior economist with the State Economic Analysis Division. "Lower energy prices, particularly natural gas, lead to the State shedding

over 6000 mining industry jobs, but despite this, Wyoming's mineral production counties continued to rank above the statewide average for cost of living. Although people lost their jobs, Wyoming's economy was still performing better than the nation, therefore a significant out-migration from mineral counties was not seen."

Teton County continued to rank as the most expensive county to live in Wyoming. "Driven by the highest housing costs in the State and the resort nature of the area, Teton County claimed the top spot of the comparative index for the fourth quarter of 2009," commented Ballard. "The **Housing** index value of 155 in Teton County indicates that housing related costs are 55% higher than the rest of the State, on average. These higher housing related costs were the main factor in driving the overall cost of living in the county to a level that was 31% higher than the remainder of Wyoming."

ANNUAL INFLATION RATES

Tables II and **III** show estimated Wyoming inflation rates. **Table II** shows estimated inflation rates for all categories, and the respective category weights. **Table III** shows the estimated annual **AII Items** inflation rates for the five regions of the State, as well as statewide rates.

The Wyoming annual **All Items** inflation rate for the fourth quarter of 2008 through the fourth quarter of 2009 was 2.7%. The inflation rate represents the percent change in the price level of a standard basket of selected consumer items priced this quarter, compared with the price level of the same goods recorded one year ago.


Statewide inflation for the fourth quarter of 2009 was the same rate (2.7%) experienced by the rest of the nation. "Significantly higher gasoline prices in the fourth quarter of 2009, as compared to year ago levels, caused another spike in **Transportation** related costs," noted Ballard. "Statewide, during the fourth quarter of 2008, regular unleaded gasoline averaged around \$1.41/gallon. A year later, regular gasoline averaged \$2.45/gallon. The **Transportation** category inflation rate of 16.9% greatly influenced the overall inflation rate of 2.7% for the last quarter of 2009."

During 2009, national inflation as measured by the Consumer Price Index (CPI) posted eight consecutive months of year-over-year deflation. "This highlights the severity and depth of the recession that deflation was seen for a majority of 2009," noted Ballard. "As the nation pulls out of the recession, Wyoming will probably lag in its recovery. Energy prices will play a significant role in determining the timing of a full economic recovery for Wyoming."

The data were weighted by population to more accurately represent the price changes experienced by the majority of consumers in Wyoming. Nationally, the inflation rate from December 2008 to December 2009 was 2.7% (CPI-U), as reported by the U.S. Department of Labor, Bureau of Labor Statistics.
