Census 2000 Data Products

Census 2000, the largest peacetime effort in the history of the United States, yields a wealth of data which have virtually unlimited applications. A complete line of Census 2000 data products will soon be available to meet these requirements. **100-Percent Data Products** are tabulated from 6 questions asked of every person in the nation. **Sample Data Products** are from additional questions asked of a sample of homes (about 1 in 6).

When will data from the census be available? The state total population counts will be released before December 31, 2000. By April 2001, all states will receive redistricting counts by race and ethnicity for small geographic areas. Other detailed demographic, economic, and social data products will be released on a flow basis from June 2001 through mid 2003 (see page 2).

How will the census data be made available? Detailed results of Census 2000 will be available in a variety of formats and media, including the Internet, CD-ROMs, DVDs, and printed reports. Generally, most data products will be released first on the Internet - click on American FactFinder on the Census Bureau's homepage (www.census.gov).

For what geographic areas will the data be tabulated? States; Counties; Cities and Towns; Census tracts (small statistical division of a county averaging about 3,800 persons); Block Groups (BG - a collection of census blocks within a census tract with population of approximately 1,200); Blocks (generally bounded by streets, rivers, or other physical features).

Employment and Per Capita Income

According to the estimates recently released by the U.S. Bureau of Economic Analysis, the number of full-time and part-time jobs increased 2.0 percent for Wyoming, from 310,422 in 1997 to 316,542 in 1998. The growth rate for the nation was 2.5 percent over the same period. Both Teton and Niobrara counties showed the most substantial increase of more than 4 percent, respectively. As a matter of fact, all counties recorded job growth between 1997 and 1998.

Wyoming's per capita income (PCI) for 1998 was \$24,312, an increase of 3.0 percent from 1997. The overall national PCI was \$27,203 in 1998, up 4.9 percent from a year ago level. Per capita personal income is the annual Total Personal Income (TPI) of residents divided by resident population. TPI is the sum of net earnings by place of residence, rental income, personal dividend income, and transfer payments.

Teton County had the highest PCI in the state, at \$52,723; while Big Horn recorded the lowest figure of \$17,759 in 1998. Albany and Natrona counties exhibited the most significant growth of 5.0 and 4.9 percent, respectively, from 1997 to 1998. In contrast, Niobrara County suffered a decline of nearly 10 percent during the same period (see page 3).

1997 County Income and Poverty Estimates

Wyoming's median household income in 1997 was \$33,197, a substantial increase of 8.3 percent from the level measured in 1995. The total number of poor persons statewide in 1997, at 57,421, increased 4.1 percent from 1995's level. The number of poor people as a percent of the total state population increased slightly from 11.5 in 1995 to 12.0 percent in 1997. The number of related poor schoolage children (ages 5-17) in families totaled 12,170, while the poverty rate for this category was 12.6 percent in 1997.

The poverty rates for all persons in 1997 increased from the 1995 level in 16 counties, with the most significant hikes realized in Hot Springs, Johnson, and Weston counties. School-age children poverty rates in Hot Springs County went up notably from 11.1% to 14.4%. All counties but Fremont showed increases in median household income from 1995 to 1997, with 7 counties demonstrating over 10 percent expansions.

The average poverty threshold for a family of four in 1997 was \$16,400 in annual income, compared to \$15,569 in 1995 (see page 4).


